# A message from the superintendent

I hope this letter finds you happy, healthy and energized for the new year! To keep you informed on issues impacting your school community, I have highlighted a few key topics below.

#### **NYS Zero Emission School Transportation Regulations**

As you may or may not know, in early 2022, Governor Hochul announced a zero-emission school transportation initiative. Under current legislation, starting in 2027, all school-based transportation purchases must be zero-emission, and by 2035, all school-based transportation on the road must be zero-emission. Currently, the only available zero-emission school vehicles are electric vehicles that contain rechargeable batteries. Meeting this mandate will be a challenging and complex process, requiring a great deal of collaboration on the state and local levels. The regulations around zero-emission transportation are evolving rapidly, and we are working hard to address the changes set forth by the state. Though the aggressive timeline required by these regulations poses a significant challenge to the District, we have begun the process of studying the necessary steps and are exploring all funding options such as various grant opportunities to transition our current bus and vehicle fleet to electric power by 2035. We will keep our school community posted on all updates related to this multifaceted topic.

#### **NYS Native American Mascot Ban**

Last year, I communicated with our District about our shift away from the Native American imagery that is used to represent our interscholastic athletic teams at WG. As I stated last January, the name "Senecas" remains in place, but we have shifted our imagery to that of our unique geography and that of Seneca Lake. This year, we began the process of creating a new logo to represent our teams. Last month, the New York State Education Department (NYSED) ordered a formal ban on all "Native American team names, logos, and/or imagery." Thus far, we believe our direction will be approved by NYSED. However, we have paused logo development, and we are awaiting formal guidance from our regulatory authorities before moving forward.

#### Capital Improvement Project Wrap Up

The capital improvement project that began with the installation of our multi-purpose turf athletic fields has wrapped up with the completion of our extensive roofing projects. Our Business Office is working hard with our architects, engineers and construction managers to finalize the project. Again, we want to thank the community for your continued support of the improvement to our District facilities.

#### **Budget Development**

In December, the District began the budget development process. Budget presentations will be delivered to the Board of Education throughout February, March and April. 

The Affordable Connectivity Program is an FCC program that helps connect families and households struggling to afford internet service.

#### The benefit provides:

- Up to \$30/month discount for internet service;
  Up to \$75/month discount for households on
- qualifying Tribal lands; and
- A one-time discount of up to \$100 for a laptop, desktop computer, or tablet purchased through a participating provider.

#### WHO IS ELIGIBLE?

A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the Federal Poverty Guidelines, or if a member of the household meets at least one of the criteria below:

- Participates in any of the following assistance programs: SNAP, Medicaid, Federal Public Housing Assistance, Veterans Pension or Survivor Benefits, SSI, WIC, or Lifeline;
- Participates in any of the following Tribal specific programs:
   Bureau of Indian Affairs General Assistance, Tribal
   TANF, Food Distribution Program on Indian Reservations, or
   Tribal Head Start (income based);
- Participates in the Free and Reduced-Price School Lunch Program or the School Breakfast Program, including through the USDA Community Eligibility Provision;
- Received a Federal Pell Grant during the current award year; or
   Meets the eligibility criteria for a participating broadband provider's existing low-income internet program.

Contact your preferred participating rovider to select an eligible plan and hav the discount applied to your bill.

Some providers may have an alternative application that they will ask you to complete.

Eligible households must <u>both</u> apply for the program <u>and</u> contact a participating provider to select a service plan.

# Immunization update

In July 2022, the New York State Health Department reported paralytic polio in a young adult who was unvaccinated. The United States is now the only

country in our hemisphere to report a case of polio acquired here. This unfortunate event has refocused our attention on the importance of vaccination and the role of school vaccination requirements in ensuring individual and community protection. It is essential for the health and safety of students



and staff, and the public at large, that all schools comply with Public Health Law Section 2164 and associated regulations at 10 NYCRR Subpart 66-1 regarding school immunization and/or immunity coverage.

Children attending day care and pre-K through grade 12 in New York State must receive all required doses of vaccines on the recommended schedule in order to attend or remain in school. This is true unless they have a valid medical exemption to immunization. This includes all public, private and religious schools. A medical exemption is allowed when a child has a medical condition that prevents him/her from receiving a vaccine. There are no nonmedical exemptions to school vaccine requirements in NYS.

The CDC's Advisory Committee on Immunization Practices (ACIP) establishes the recommended vaccine schedule and determines when vaccines are due.

#### Important school immunization information

Within 14 days of the first day of school or day care, parents must:

- Show proof of their child's up-to-date vaccinations, OR
- Provide a valid medical exemption from vaccination

In order to attend or remain in school or day care, children who are unvaccinated or overdue must receive at least the first dose of all required vaccines within the first 14 days. They also must receive subsequent vaccines in the series within a 14-day period of when they are due to complete the immunization series.

# Vaccines required for day care, pre-K and school attendance

- Diphtheria and Tetanus toxoid-containing vaccine and Pertussis vaccine (DTaP or Tdap)
- Hepatitis B vaccine
- Measles, Mumps and Rubella vaccine (MMR)
- Polio vaccine
- · Varicella (Chickenpox) vaccine

# Additional vaccines required for middle school and high school

- Tdap vaccine for grades 6-12
- Meningococcal conjugate vaccine (MenACWY) for grades 7-12
  - Students in Grade 12 need an additional booster dose of MenACWY on or after their 16th birthday

#### Additional vaccines required for day care and pre-K

- Haemophilus influenzae type b conjugate vaccine (HiB)
- Pneumococcal Conjugate vaccine (PCV)
