At orientation held on August 11-12, parents/families will receive an informational packet which includes an orientation letter that describes daily school operations, key contact information for school personnel, and a parent volunteer survey which offers ways in which parents/families can be involved throughout the school year. The survey explains parents'/guardians' roles and how they can be involved. Also included in the packet is a school calendar with the year's activities. Parents will sign documentation acknowledging receipt of this packet.

Teachers and school personnel contact parents regularly by means of phone calls, Google Meets/ Classroom, and virtual/in-person conferences. Students and parents can access Google Classroom and view class announcements, homework/classwork, and instructional videos posted by the teacher and email the teacher with questions, concerns, or comments. Student planners, distributed on the first day of school, are also used for two-way communication. Barton Remind messaging system and Thrill Share have been implemented by means of mass communications to advertise meetings, conferences, and volunteer opportunities.

Meetings with parents will be offered before/after school or during a teacher's conference period as needed and in a format that is convenient for all parties involved. These meetings could take place in person or virtually, however is determined to be the best suitable.

Parent and Family Engagement compacts are on file for every student with all stakeholders' signatures. This compact is reviewed each year for the following year.

Parent/ Teacher conferences will be held in the fall on October 5th and 7th from 3:30 to 6:30. Conferences in the spring will be on February 15th and 17th from 3:30 to 6:30 for parents to meet with teachers. Kittens Conferences for next year's academic planning will be held on April 14.

Progress reports will be sent home mid-nine weeks so that parents are aware of their student's progress and to provide an opportunity for partnership in guiding their student in improving their grades. Report cards will be sent to home at the end of each nine-week period.

A virtual/hard copy binder will be utilized for record keeping of the parent interest survey results and for parent volunteer sign in/out data for staff use.

South Arkansas Regional Health and Methodist Family Services provide student mental health services. Wyatt Baptist Church provides mentoring for selected students. Community leaders such as the fire chief, the chief of police, and business leaders are utilized as guest speakers in our career development classes.

Barton's Parent Resource Center is located in the Barton Library. Parents and family members can check out resources regarding parenting, child development, and middle/junior high guides. Parents are encouraged to use the DESE website for parents at http://dese.ade.arkansas.gov. (http://dese.ade.arkansas.gov.) Parents are encouraged to visit the Eldorado School District's website for food and nutritional meal planning. ELA teachers send home Renaissance home connect letters with information on how parents can access their student's reading levels and view their progress on reading quizzes. Parents are given eschool access codes to access their student's current academic performance. Students and parents use Google Classroom to have access to materials being used in the classroom. Curriculum maps based upon Arkansas Standards are uploaded to the school's website for parents. Pre-AP syllabuses are sent home the first week of school for ELA, math, social studies, and science.

At Parent Teacher Conferences, parents will receive a copy of their student's state assessment, Act Aspire, score results. Parents will be informed on how to interpret those results and what programs are in place in order to foster greater academic performance.

In order to prepare parents for volunteering, a volunteer training video is provided on the school district website. Parent Volunteer Training is offered on a one-on-one basis as needed.
