**BOARD MINUTES**  
**July 15, 2021 @ 6:00 p.m.**

President Monica Walker called the Board Meeting to order at 6:00 pm with a quorum established.

Director James Fowler made the motion to approve the agenda. Seconded by Director Rachelle Motsinger. Motion carried 5-0.

Director Tara Adkins made the motion to approve the consent agenda (approval of the minutes, authorization of the payment of bills {Director Adkins}) Seconded by Director Victor Orta. Motion carried 5-0.

**New Business:**

Director Tara Adkins made the motion to set the Tax Rate Hearing for the 2021-2022 school year for August 16, 2021 at 5:50 p.m. in the school library. Seconded by Director Victor Orta. Motion carried 5-0.

Director Tara Adkins made the motion to amend the April 19, 2021 board minutes to state "Non-certified contracts will also be reflective of the same percentage increase (4.8%) prorated to their contract length with the exception of custodial staff, which will see a 7% increase to stay ahead of the state minimum wage increases." Seconded by Director Victor Orta. Motion carried 5-0.

Director Victor Orta made the motion to approve the individuals highlighted on the Coaching Positions List for the 2021-2022 school year, as presented in the board packet, pending completion of satisfactory background checks. Seconded by Director James Fowler. Motion carried 5-0.

Director James Fowler made the motion to approve the revised extra duty stipends schedule for the 2021-2022 school year, as presented in the board packet. Seconded by Director Rachelle Motsinger. Motion carried 5-0.

Director Tara Adkins made the motion to approve the MSBA Full Maintenance Service Agreement for the cost of \$3,175.00. This agreement allows the district access to all MSBA resources, provides the policy updates and changes, and allows access to their attorneys. Seconded by Director Victor Orta. Motion carried 5-0.

Director James Fowler made the motion to increase lunch prices \$0.05 for the 2021-2022 school year, bringing the K-4 price to \$2.65 and the 5-12 price to \$2.85. This increase ensures we are moving closer to the paid lunch equity weighted average of \$3.09, which is set by the federal government. Seconded by Director Rachelle Motsinger. Motion carried 5-0.

Director Rachelle Motsinger made the motion to set the 2021-2022 K-12 nonresident tuition rate at \$4250.00 (unchanged from previous years) and the 2021-2022 preschool nonresident and resident tuition rate at \$2565.00 (\$15.00/day). Both prices are figured on 171 attendance days. Seconded by Director Victor Orta. Motion carried 5-0.

Director Tara Adkins made the motion to set the 2021-2022 substitute teacher pay at \$100.00 per day for the standard daily rate and \$120.00 per day for the long-term substitute rate. Seconded by Director James Fowler. Motion carried 5-0.

President Monica Walker adjourned the meeting at 6:42 pm.
