Junction City Elementary parent facilitator/elementary librarian works with Head Start to schedule days when their students can visit the library for a story or library tours. JCES kindergarten teachers attend an end of the year Head Start meeting to inform parents what is expected of their child as they enter kindergarten at JCES.

The JCES principal is responsible for conducting the Annual Title 1 meeting in the Fall of 2021 and the Spring of 2022. This meeting is conducted separately from regular parent engagement meetings.

Orientations for K-12 are prior to the first student day of school each year in August.

The Parent and Family Engagement Facilitator for the elementary is Sharon Harris and the high school Parent and Family Engagement Facilitator is Deneen Miller.

Regular parent meetings are held where parents are given a report on the state of the school and an overview of the school's academic curriculum. The annual report to the public will be held October, 2021. Invitations to these meetings are on the JC school website and in the local newspaper.

A Back-to-School Backpack Bash will be held in August 2021. This will supply students with backpacks and school supplies. Area cosmetologists will volunteer and provide hair cuts for our students.

Open House will be held in August, 2021. Parents and students will meet the teachers, see their classroom, and obtain schedules for the upcoming school year.

A "Bingo For Books" Literacy night will be held. Parents and their children will play bingo. Prizes for a winning card will be a book. A table of books by age levels will be set up for parents and students to choose from.

A community-wide Black History Program will be held in February showcasing our student's learning of Black history. The program will also include motivational speakers.

JCES will have two parent/teacher conferences per school year. The first conference is September, 2021. The second conference will be held February, 2022. A "Bingo For Books" Literacy night will be held. Parents and their children will play bingo. Prizes for a winning card will be a book. A table of books by age levels will be set up for parents and students to choose from.

Parent Facilitators at Junction City Elementary and Junction City High School worked with the JC superintendent to form a committee of teachers, community members, and Junction City Alumni. From this committee, various activities at the elementary and high school campuses are discussed and planned. This committee was formed with the idea that a community presence at school will help to bridge the gap in our low achieving students.

Junction City Elementary Faculty will complete 2 hours of professional development by participating in the Literacy night titled the "Bingo For Books" Literacy event.

The Junction City website has a link for parents to gain access to developmentally appropriate learning activities at home, nutritional helps, and other parenting issues that parents may encounter. Materials (pamphlets/flyers) will also be available in the school parent center located in the elementary library.

The Junction City School District was awarded the 21st Century Grant. The program teaches students to utilize technology, build and strengthen relationships, and engage in innovative educational and enrichment activities that will promote the positive development of the whole child. The after school program will begin at 3:15. Students will receive a healthy snack.

Then, students will be escorted by certified/classified staff to a grade specific classroom. Staff will assist students with completing daily homework and/or studying for tests. Next, learning

during the academic lab hour will be from 3:30-4:30 and will be based on the needs of the students as determined through collaboration between the regular classroom teachers and the after school staff. In addition, the last hour of the afterschool program will include enrichment and recreational activities. This program will begin at 4:30 and end at 5:30. Enrichment activities will be led by staff, volunteers, community partners and other stakeholders with expertise in the related field. Students will choose from a list of activities to participate in each cycle. Students will participate in hands on, inquiry based, project based learning, service learning, multi-sensory activities, and technology enhanced learning.

A career fair for students in grades 6-12 will be held during the spring semester of 2022. Industries, colleges, and local businesses will participate to enlighten students and parents of future employment opportunities. They will also give insight as to what employability skills and schooling are necessary in order to be successful in the workplace.
