8.0 REPORTS AND PRESENTATIONS

8.1 Administration Reports – (enclosures)

8.1.1 Dr. Gretchen Skrotzki/Garrett Carr, Bishop Elementary School – Dr. Skrotzki shared that they wrapped up the school year, and it felt like we ended on a normal year and it felt nice. Summer School Academy is underway, they have 146 students on campus, and Dr. Skrotzki appreciates all the teachers and staff for spending part of their summer at Summer Academy. She is super hopeful and excited for next school year. Vice Principal, Garrett Carr and that they were able to give away three bikes donated from ICOE, two 3rd graders, and one 2nd grader, and a huge shout out to Aerohead Cycles who donated the bikes back in 2019.

8.1.2 Derek Moisant/Danielle Grate, Home Street Middle School – Mr. Moisant shared that grades are back in the 3.0 range, and he feels it's due to being back in seat and getting instruction. Summer School is off and running, and HSMS has a circus for PE, they are throwing things in the air and having a great time juggling between each other, it's super awesome seeing everyone happy. The promotion ceremony was a success, everyone was happy with how fast and smooth it went. Mr. Moisant wanted to thank his Vice Principal, Danielle Grate for the past two years of being his right hand, and that she will be missed.

8.1.3 Dave Kalk/Jordan Rose, Bishop Union High School – Mr. Kalk shared that all three graduation ceremonies were great, with all things considered, he is grateful they could pull it off and the weather was great. Summer School attendance was originally at 133 enrolled, but actually 116 was the attendance on the first day. Mr. Kalk is happy with the attendance.

8.1.4 Patrick Twomey, Alternative Education, (Palisade Glacier High School, Keith Bright and Bishop Independent Study) – Superintendent, Katie Kolker shared that the Palisade graduation ceremony promoted nineteen students, while Bishop Independent Study promoted five.

8.2 Katie Kolker, BUSD Superintendent

8.2.1 2020-2021 School Year ~ Superintendent, Katie Kolker was happy to share that we did it!! We can take away from this year: what we lost and what we can take and build from it; transition instructional models various times throughout the year, some teachers had to do this ten times with hybrid, distance learning, and in-seat. We have a better understanding of students' lives outside of school and how resilient they are. We rely on our staff to put students first, embrace new technology, and reach students in creative and unusual ways, and we have what it takes to "do hard things". Today is the big day, June 15th, the day California opens up, but not much change for schools. Schools still follow CDPH guidelines, wearing masks, hand hygiene, and social distancing is still mandated.

10.0 DISCUSSION/APPROVAL ITEMS:

- 10.1 Discussion/Approval, Honors World History Curriculum Adoption (enclosure) – Kathy Zack shared that she feels Mrs. Greene knows what she's talking about since she's been using it for 3 years.

ACTION: A motion to approve was made by Kathy Zack, seconded by Steve Elia. None opposed, no abstention and the motion carried by 5-0

- 10.2 Discussion, Proposed Local Control Accountability Plan (LCAP) (enclosure) –

ACTION: A motion to open the discussion was made by Dr. Taylor Ludwick, seconded by Kathy Zack. No action was taken.

Superintendent, Katie Kolker stated that there are three main goals:

1. Provide high quality instruction to increase student achievement and close performance gaps for all students.
2. Provide a positive school environment that fosters student engagement and connectedness. Provide integrated student support services that will increase school attendance and address Social Emotional Learning (SEL) that supports student engagement, including whether students attend school or are chronically absent, and highlights school climate and connectedness.
3. Establish a culture of data-driven continuous improvement to assess and ensure positive student outcomes. Provide multiple avenues for advancement/success utilizing the MTSS framework districtwide; cultivating a growth mindset for students and staff; providing high quality professional development targeted to best meet student and staff needs.

Kathy Zack thanked Superintendent Kolker for doing this very exhausting task.

Dr. Claudia Moya-Tanner shared that she had read most of it, as it was easy to follow, and realistic.

Steve Elia thanked Katie, he shared it's an amazing process too and it's nice to see the vision we are setting for the next three years.

- 10.3 Discussion, Proposed Budget for 2021-2022 School Year (enclosure)

ACTION: A motion to open the discussion was made by Kathy Zack, seconded by Steve Elia. No action was taken.

Dr. Claudia Moya-Tanner thanked CBO, Midge Milici for her hard work on the budget.

Midge Milici stated, the budget is straight forward, a lot of money in there, and as we all know, we have quite a bit of money from state and federal resources. This is a nice problem to have considering things we haven't been able to do for a while. We are looking at making some modernization updates to the 45 year old BUHS main building. We are also looking at the math buildings as well since there are no filters in the math building.

Kathy Zack asked how quickly can these things be fixed? Mrs. Milici wasn't sure, but tomorrow she would be discussing once the item is approved.

Dr. Taylor Ludwick asked if the reserves goes from 21% down to 17% for now? Mrs. Milici said we have no idea next year what our ADA will look like, and keeping lower class sizes for a couple of years and offering much needed programs is worth the deficit.

Kathy Zack thanked Midge Milici for her fantastic job on the budget.

- 10.4 Discussion/Approval, Modernization of the Heating & Cooling Systems at BUHS (enclosure) –Midge Milici share that normally on construction projects we need to go out to bid, but due to short timeline, the pandemic emergency Ed Code allows for this. If the board passes with unanimous vote, Inyo County Superintendent can give us permission. I've already talked to Barry Simpson, ICOE, Superintendent, and he said he'd approve this if the board decides to move forward.

Kathy Zack feels that with fire season upon us, she'd like to have good ventilation in this building.

Dr. Taylor Ludwick feels this is the right way to go, but wants to make sure we are doing this the right way and this process is air tight, we're not doing an RFP. Midge Milici assured Dr. Ludwick that yes, she's talked with county officials and Curt Van Nest (Bishop Heating and Plumbing) who knows these units better than anyone else in the community. The third floor in the main building reached 80-90 degrees during finals week. We've been piecing it together for years, and making parts. Some of serial numbers dates back to 1962, and thirty classrooms are tied to one unit.

10.5 Discussion/Approval, Resolution 20-21-06, GASB 84 Establishing Fund 08

(enclosure) – CBO, Midge Milici shared that the GASB governmental standards board, nationwide organization, oversees government spending. The committee decided ASB funds should be ran through the districts since the funds were in schools control, and they had to be accounted for in our audit. Once a year, Mrs. Milici will take all statements, come up with what the assets are in our ASB accounts and enter the amount as one line item.

10.6 Discussion/Approval, 2021-2022 Consolidated Application (ConApp) –

CBO, Midge Milici shared that the annual ConApp is how we apply for federal funding, Title I, II, III and a small amount of Title IV that we sweep into Title I.

ACTION: A motion to approve was made by Kathy Zack, seconded by Virginia Figueroa. None opposed, no abstention and the motion carried by 5-0

10.7 Discussion/Approval, AR 5132, Dress Code (enclosure) –

Superintendent, Katie Kolker shed a little light on this item, as there has been conversations with students, Student Senate, and staff regarding an updated student dress code. What I'm bringing forward, is AR (Administrative Regulation), along with BUHS Principal, Dave Kalk, and Student Senate Representative, Clara Place. Clara Place thanked Mrs. Kolker, and Mr. Kalk for addressing the subject, and bringing attention to it this Spring. BUHS students want the dress code to be equable for all students, it's very minimal to actual dress code. The Senate shared the rational from the students' perspective, and asks to update the dress code in a manner that works for all genders and all body types.

Steve Elia asked if this represents all students? Clara said yes, that even the language and nuance addressing different body types, gender, and we feel this had been achieved and step in the right direction. Mr. Kalk shared the input is from a number of teachers, students, and not representing any one group or club. It's been a great experience and we can all learn from it, being discrete, not belittle anyone, and not call out a student in front of other students. We need to train our staff to be aware of comments, even if they are not intended to be hurtful or belittle.

Dr. Taylor Ludwick thinks this is a step in the right direction, its written well and professional, but also seems like the policy could be manipulated.

Superintendent, Katie Kolker feels there was a grey area in the spring when staff didn't know what to do, old criteria vs new criteria.

Steve Elia is wondering if there is going to be a training for students and staff so they understand what happened last year. Mr. Kalk said yes, and they will find something to address these needs.

Superintendent Kolker shared that education for staff, students and parents will need to be shared before school starts. She also shared that each school site should have their own dress code policy that is age appropriate.

Dr. Claudia Moya-Tanner is glad students had big voice, and teachers and staff had voices too. She asked if parents and student council was included in the discussion? Mr. Kalk shared that they were not, but it was a very civil and respectful approach, and a moment to give students a voice, not thinking there's risk having them help us with this.

Superintendent Kolker shared that the template will be shared with the other sites to address their policy. Kathy Zack feels this makes most sense, and letting each site do their own since they know what their site needs.

Dr. Claudia Moya-Tanner likes the ability to be more specific per site, i.e.: school farm would be different, just like kindergarten footwear will look different from another site.

Steve Elia likes having a template for other schools. He also hopes we can look at model of decision making and we are getting good at doing hard things, dress code is not an easy topic.
