#### MONITORING: NO CONFIRMED CASES IN BUCKS COUNTY

#### SCHOOL LANE CHARTER SCHOOL WILL REMAIN OPEN

- SLCS will remain in contact with the Bucks County Department of Health and the Pennsylvania Department of Education
- Monitor the CDC website & share information with staff and families
- Monitor activities locally and regionally
- Daily cleaning of classrooms, bathrooms, hallways and stairwells, cafeterias and common spaces

## LIMITING: CONFIRMED CASES IN LOWER BUCKS COUNTY

#### SCHOOL LANE CHARTER SCHOOL WILL REMAIN OPEN

- SLCS will remain in contact with the Bucks County Department of Health and the Pennsylvania Department of Education
- Will continue all measures in the Monitoring Stage
- Consider limiting large audience attendance (300+ individuals) in our school buildings
- Consider postponing student and staff travel in areas that are a focus of infection; reschedule if possible

# POSTPONING: GROWING NUMBER OF CONFIRMED CASES IN BUCKS COUNTY

## SCHOOL LANE CHARTER SCHOOL WILL REMAIN OPEN

- SLCS will remain in contact with the Bucks County Department of Health and the Pennsylvania Department of Education
- Will continue all measures in the Monitoring Stage
- Consider postponing all travel and field trips, rescheduling if possible
- Consider suspending parent volunteers
- Consider postponing all district-sponsored events, rescheduling if possible
- Consider postponing all athletic and extracurricular activities, rescheduling if possible
