# 8. <u>Budget Officer</u>

Mark Mulvihill is designated Budget Officer for the InterMountain Education Service District for the 2023-2024 year.

#### 9. Official Auditor

The auditing firm of Dickey and Tremper, LLP is designated the Official Auditor for the InterMountain Education Service District for the 2023-2024 year.

## 10. Legal Counsel

The firms of Anderson Hansell, PC and Garrett Hemann Robertson P.C., GHR are designated the Legal Counsel of the InterMountain Education Service District for the 2023-2024 year.

## 11. <u>Depositories for Funds</u>

For the 2023–2024-year, Bank of Eastern Oregon, and Umpqua Bank are designated the depositories for funds, and the InterMountain Education Service District is authorized to participate in the Local Government Investment Pool.

# 12. Insurance Agent of Record

#### 14. Per Diem

For qualified travel, employees of the InterMountain Education Service District will receive the posted IRS rate for in-state mileage. Furthermore, per diem will include lodging at the single party rate and reimbursement for meals at the current year standard rate as posted by the US General Services Administration.

#### 16. Substitute Teacher Rates

For the 2023-2024 year, the substitute teacher rate is set at \$206.35 per 8-hour day or \$25.79 per hour for the first 10 days, and for a substitute employed for more than 10 consecutive days in any one assignment, a minimum of \$249.68 per 8-hour day or \$31.21 per hour.

#### C. Authorization for Interfund Loans

For the 2023-2024 year, the board of Directors of the InterMountain Education Service District may authorize short-term, non-interest loans between funds when necessary due to timing of receipts and expenditures.

D. <u>Authorization for Umatilla, Morrow, Union, Baker, and Malheur County</u> Investments

For the 2023–2024-year, authorization is granted by the Board of Directors of the InterMountain Education Service District for the investment of any money held by the Finance Officer of Umatilla County and the County Treasurers of Morrow, Union, and Baker, and Malheur Counties.
