The Board of School Trustees (Board) of the Logansport Community School Corporation (Corporation), Cass County, Indiana, met in regular session at LCSC Administration Building, 2829 George Street, Logansport, IN 46947, at 5:00 P.M. on Monday, July 26, 2021.

There being no further business to come before the Board, the meeting was adjourned at 5:58.

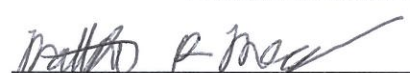
