## **Electronic Device**

## Student Agreement 2023-2024

For students to receive a district-issued Electronic Device, the student and parent/guardian are required to sign the Electronic Device Policies Checklist. Signing the Electronic Device Policies Checklist indicates compliance with this Agreement. SEGSD does not authorize any use of the Electronic Device, which is not conducted in strict accordance with this Agreement and all other applicable District policies.

- 1. I have reviewed and will abide by the SEGSD Electronic Device Guide and district policies at all times. This includes both on and off school grounds.
- 2. I understand that my Electronic Device is subject to inspection by staff at any time and that it remains the property of SEGSD. I also understand that the SEGSD retains the right to collect the Electronic Device at any time to alter, add or delete installed software or hardware.
- 3. I will keep my Electronic Device secure at all times. I will not share my device or passwords with anyone.
- 4. I will not disassemble, repair, damage, hack, or corrupt the security of the Electronic Device.
- 5. I understand that I am not allowed to install any apps without teacher permission.
- I understand that I am responsible for any malicious damage or loss of the Electronic Device. Malicious
  damage or loss will result in paying Electronic Device Repair Fees for Damage, Loss, or Failure to Return.
- I will notify my school's principal in the event of equipment loss/theft/damage/failure within one school
  day. Stolen devices must be reported to the police immediately.
- 8. I will return the Electronic Device and cables in good working order as directed. I understand that it is my responsibility to reimburse the SEGSD for any costs associated with damaged, broken, or missing equipment.
- 9. I understand that violating SEGSD Electronic Device Agreement may result in having my use privileges of the Electronic Device suspended or revoked. Additionally, I may be further subject to disciplinary action in accordance with school policy or other legal action.
- 10. I hereby agree to release, indemnify and hold harmless SEGSD as well its Board members, teachers, employees, administrators, and adult volunteers from any claims arising from conduct inconsistent with the SEGSD Electronic Device Agreement and the Internet Access and Network Resources Student Acceptable Use Policy. This includes, but is not limited to, claims arising from downloaded materials or relationships established with people online, whether such claims arise from Internet use through school accounts or personal accounts.
