Bloomingdale Public Schools wishes to have all students in person and have school as normal as possible. With that being said, our COVID protocols are as follows:

- Cafeteria, classrooms, and outdoor areas (as appropriate) will be used for students to eat meals at school.
 - Cafeterías, aulas y las áreas al aire libre (según corresponda) se utilizarán para que los alumnos coman en la escuela.
- Students and staff will wash hands as needed before and after meals.
 Los estudiantes y el personal se lavarán las manos según sea necesario antes y después de las comidas.
- Disposable plates, napkins and utensils will be used.

Student Transportation **Transporte de Estudiantes**

- Students and staff are not required to wear masks at this time.
 Los estudiantes y el personal no están obligados a usar máscaras en este momento.
- Hand sanitizer will be available.
 El desinfectante de manos estará disponible.
- Buses shall be disinfected after each student transport/route.
 Los autobuses se desinfectarán después del transporte / ruta de cada estudiante.
- Established deep cleaning regimen shall be followed by all transportation staff.
 Un régimen de limpieza profunda debe ser establecido y requerido por todo el personal de transporte.

Hygiene & Cleaning

Higiene y Limpieza

 Hand sanitizer with at least 60% alcohol will be provided in classrooms, entrances and hallways.

Paper towels and signs reinforcing proper handwashing techniques will be supplied.
 BPS building staff may request refills via the building main office.

- Staff will teach and reinforce handwashing with soap and water for at least 20 seconds and/or the safe use of hand sanitizer that contains at least 60% alcohol.
 - El personal enseñará y reforzará el lavado de manos con agua y jabón durante al menos 20 segundos y / o el uso seguro de desinfectante para manos que contenga al menos 60% de alcohol.
- Staff and students will cough and sneeze into their elbows or cover with a tissue. Used tissues should be thrown in the trash and hands washed immediately using proper hand hygiene techniques.
 - El personal y los estudiantes toserán y estornudarán en sus codos o se cubrirán con un pañuelo. Los pañuelos de papel usados deben tirarse a la basura y lavarse las manos inmediatamente utilizando técnicas adecuadas de higiene de manos.
- 2. Describe how the LEA will ensure continuity of services including but not limited to services to address the students' academic needs, and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.

Bloomingdale Public Schools resumed full in-person learning with continuity of all services in August 2021 for grades young 5s-12. This has continued for the 2022-2023 school year. The district does provide an online program through Strive for those student who qualify. We will contine to offer free lunch in all of our buildings for the upcoming school year to meet the nutritional needs of our students.

Ensuring Students' Academic Needs:

As in previous years, Bloomingdlale Public Schools will continue its use of the NWEA assessments in reading and mathematics for 22-23 for students in grades K-8. BPS will report benchmark assessment data to parents and legal guardians within 30 days of students completing the assessment. The assessment will be administered three times a year: the first during the first six weeks of the school year, the second during the month of January, and the third during the spring prior to the last day of school in June. BPS will also continue to use extensive assessments in math/reading in grades K-5 to determine interventions and supports to better meet the needs of its learners in both reading and mathematics.

Using the district's continuous improvement process, APS will continue to engage stakeholders in the district's assessment system, including publicly sharing aggregate and student subgroup performance reports on NWEA results. Following the pandemic, Bloomingdale Public Schools will provide a continuity of services, as well as implementing new research-based programs and digital resources to support, enrich and accelerate student learning.

Ensuring Students' Social, Emotional and Mental Health Needs:

Our goal at Bloomingdale Public Schools is to provide a supportive environment to students. Our district offers counsleors, social workers, and/or mental health clinician at all of our sites. The landscape of teaching and learning has changed following pandemic learning. While we can anticipate that students returning in the fall will exhibit both learning and social-emotional challenges, staff and leaders at Bloomingdale Public Schools are well-prepared to support their needs. While much of this is a natural part of our existing approaches to support our BPS students, the inclusion of additional support staff for the 22-23 school year will help to provide individualized, meaningful, and appropriate socio-emotional support for our students.

Bloomingdale Public School will begin implementation of the TRAILS curriculum, a research-based approach to meet the mental health care needs of all students. TRAILS "promotes equitable access to youth mental health services." BPS schools participating in 22-23 will receive training and ongoing support to implement school-appropriate mental health programs grounded in cognitive-behavioral therapy (CBT) and mindfulness - techniques to reduce symptoms of anxiety and depression.

3. Describe how the LEA will, in planning for the use of ARP ESSER funds, engage in meaningful consultation with stakeholders. Provide an overview of how the public stakeholder input was considered in the development of the LEA's Safe Return to In-Person Instruction and Continuity of Services Plan.

From the inception of the Extended COVID Learning Plan developed for the 2020-2021 school year, staff, parents and community members have been given opportunities to

voice their opinions, provide perspectives, and offer feedback regarding plans for pandemic learning. BPS continues to utilize Board of Education meetings as a conduit to the general public, but also provided other opportunities for stakeholders to share input since 2021. To meet the requirements of Public Act 149, Section 98a, Bloomingdale Public Schools reconfirmed how instruction was delivered during the 2020-2021 school year on a monthly basis that included public input. Before an LEA Plan of Use was developed for the expenditures of ESSER III funds, input was solicited in a couple of different venues including surveys indicating how funds should be allocated. Through the regular district improvement process more stakeholder input was gathered to help make decisions around spending.

4. Periodic Review Process and Understandable & Uniform Format

Districts are required to periodically review and, as appropriate, revise their Safe Return to In-Person Instruction and Continuity of Services Plan at least every six months through September 30, 2023. Each review must include seeking public input on the plan and revising the plan after taking into account public input. The review dates are as follows:

November 2021 May 2022 November 2023 May 2023

Bloomingdale Public Schools will use the current template and make it accessible to the public. The plan will be posted publicly on the Bloomingdale Public Schools website, and accommodations can be made for those who require formats related to language or disabilities.

Assurances

- 1. The District/PSA will make their board approved Extended COVID-19 Learning Plan accessible through the transparency reporting link located on the District's/PSA's website no later than October 1, 2020.
- 2. The District/PSA will create and make available on its transparency reporting link located on the District/PSA's website, a report concerning the progress made in meeting the educational goals contained in its Extended COVID-19 Learning Plan no later than February 1, 2021, for goals its expected would be achieved by the middle of the school year and not later than the last day of school of the school year for goals the District/PSA expected would be achieved by the end of the school year.
- 3. Benchmark Assessments: The District/PSA will
 - select a benchmark assessment or benchmark assessments that is/are aligned to state standards.
 - administer the approved benchmark assessment, or local benchmark assessment, or any combination thereof, to all pupils in grades K to 8 to measure

proficiency in reading and mathematics within the first nine weeks of the school year and again not later than the last day of the 2020-2021 school year.

- 4. If delivering pupil instruction virtually, the District/PSA will
 - provide pupils with equitable access to technology and the internet necessary to participate in instruction, and
 - expose each pupil to the academic standards that apply for each pupil's grade level or courses in the same scope and sequence as the District/PSA had planned for that exposure to occur for in-person instruction.
- 5. The District/PSA, in consultation with a local health department will develop guidelines concerning appropriate methods for delivering pupil instruction for the school year that is based on local data that are based on key metrics. <u>Note: A determination concerning the method for delivering pupil instruction shall remain at the District/PSA Board's discretion.</u> Key metrics that the District/PSA will consider shall include at least all of the following:
 - o COVID-19 Cases or Positive COVID-19 tests
 - Hospitalizations due to COVID-19
 - Number of deaths resulting from COVID-19 over a 14-day period
 - o COVID-19 cases for each day for each 1 million individuals
 - The percentage of positive COVID-19 tests over a 4-week period
 - Health capacity strength
 - Testing, tracing, and containment infrastructure with regard to COVID-19
- 6. If the District/PSA determines that it is safe to provide in-person instruction to pupils, the District/PSA will prioritize providing in-person instruction to pupils in grades K to 5 who are enrolled in the District/PSA.
- 7. The District/PSA assures that
 - instruction will be delivered as described in this plan and approved by the District/PSA Board,
 - the description of instructional delivery in this plan matches the delivery of instruction to be delivered during the school year,
 - the District/PSA will reconfirm how instruction will be delivered during the school year thirty days after the approval of the plan and
 - public comment will be solicited from the parents or legal guardians of the pupils enrolled in the District/PSA during a public meeting described in PA-149.
- 8. The District/PSA will ensure that students with disabilities will be provided with equitable access to instruction and accommodation in accordance with applicable state and federal laws, rules, and regulations.
- 9. The District/PSA will ensure that two (2), 2-way interactions occur between a pupil enrolled in the District/PSA and the pupil's teacher or at least one (1) of the pupil's teachers during each week of the school year for at least 75% of the pupils enrolled in the District/PSA.
