Job Description:

- Demonstrate expertise in journalism and/or broadcasting/video production practices
- Use technology as teaching and production tools and maintain digital media platform for school newspaper
- Construct and utilize organizational models that emphasize responsibility, risk-taking, problem-solving under student leadership including production schedules that encourage scholastic journalists to mirror practices of professional journalists.
- Guide students in learning to assess their own growth through creation of career portfolios of their work, publications, photography, and digital media.
- Identify students' reading and writing strengths and weaknesses and match to appropriate interventions
- Assist in the evaluation of ongoing programs
- Consult frequently with core content teachers on matters relating to reading and writing instruction
- Work with building/district teams in their ongoing development and promotion of social/emotional interventions and services through multi-tiered systems of support (MTSS)
- Design interventions and write lesson plans detailing methods and materials
- Be knowledgeable in assessment and data collection, reporting, and analysis techniques
