Frank moved to approve the extension of the principal's contracts for one year through 2018. Bauer seconded. Murray stated he is pleased with the performance of all district principals, but is opposed to two year contracts for administration. Motion carried 6-1 with Murray opposed.

Imthurn moved to approve the employment of Shawn Gideon, Emergency Substitute. Bauer seconded. Motion carried 7-0.

Frank moved to adjourn. Bauer seconded. Motion carried 7-0. The meeting was adjourned at 8:44 p.m.
