- **Enrollment Update:** Enrollment is down about four students. The enrollment projection for the coming school year is high. There are waiting list in most grades. JH/HS are also looking to be very full. Raymon is hearing a lot of positive feed back from out of district applicants, mainly stating that they have heard wonderful things about the Echo School District. There are currently 47 students enrolled in the preschool program.
- **COVID Update:** It is still up in the air where we will be with the mask mandate once the new school year begins. Schools are expected to follow different guidance than the general public. Even if a student does not have to wear a mask to be out in public, there is a possibility they will have to wear one at school. Failure to follow the State mandates can result in loss of funding for districts that push back. COVID related topics are everchanging, which means a lot could happen over the next few months. Raymon plans to keep the board updated through the summer and hopes to have better and more concrete information by our August board meeting.
- **Summer School:** JH/HS credit recovery is underway and running smoothly. Raymon will be sending out more detailed information to parents/guardians for elementary summer school.
- **Construction Update:** Raymon took the board on a walk through to see the new building. There is still work to be done, but the construction of the building has come together nicely.
