#### UNOFFICIAL MINUTES OF REGULAR SCHOOL BOARD MEETING

THE SCHOOL BOARD OF BELLE FOURCHE SCHOOL DISTRICT NO. 9-1 MET IN REGULAR SESSION ON MONDAY, AUGUST 9, 2021, AT THE BELLE FOURCHE SCHOOL DISTRICT ADMINISTRATION OFFICE with president Tammy Clem presiding and members Tara Knapp, Greg Krajewski, Scott Reder and Mike Tyndall present. Board members Wayne Gilbert and Nita Justice were absent. Administration present: Superintendent Steve Willard, Business Manager Susan Proefrock, Principals Julie Hatling, Kevin Smidt and Mathew Raba, Activities Director Adam Nowowiejski, Special Education Director Caleb Case and Director of Facilities and Transportation Tommy Coyle. Unless otherwise noted, all Board action was by unanimous decision.

President Clem called the meeting to order at 5:15 p.m. Clem led everyone in the Pledge of Allegiance.

Motion Krajewski, second Knapp to approve the agenda as presented. Motion carried.

The 2021-2022 Belle Fourche School District American Rescue Plan/Elementary and Secondary School Emergency Relief (ARP ESSER) LEA Plan was reviewed and a public hearing was held at this time. This plan was developed using stakeholder input and will be updated as necessary.
