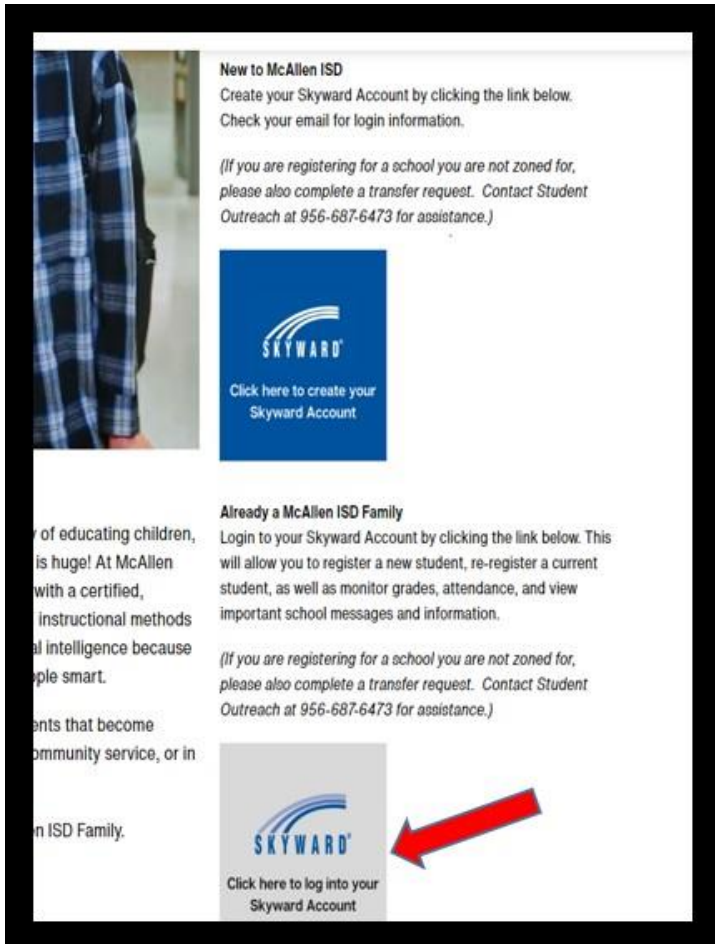

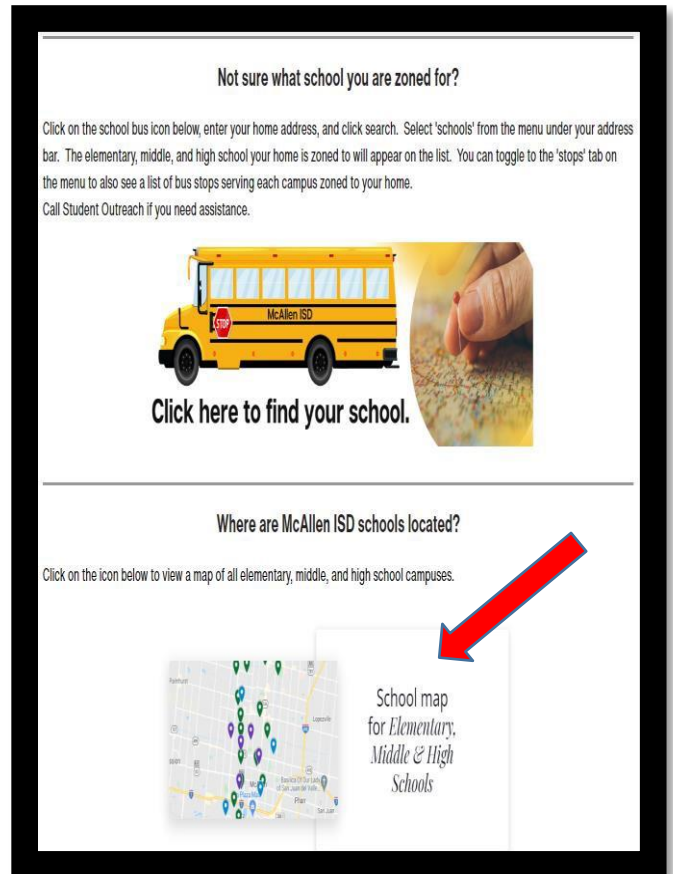
Go to www.mcallenisd.org, then Click on Register



If you are a Returning Student, click on the bottom (GREY) link, if you are a New Student to the district, click on the top (BLUE) link



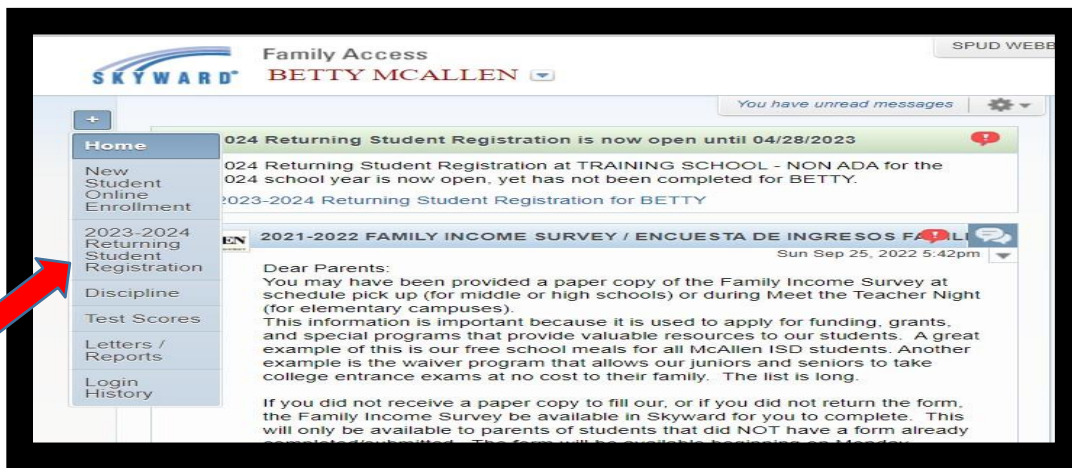

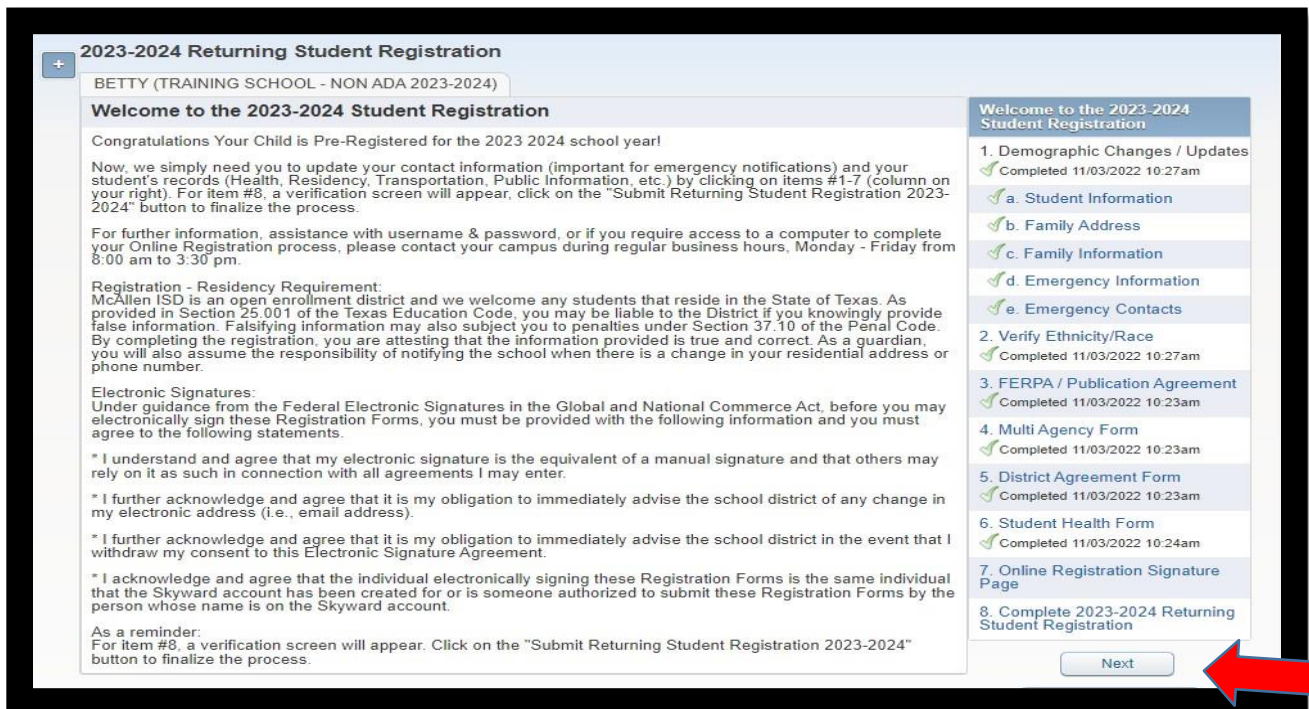
Enter your Skyward Family access account log in & password. If you don't remember your log in and password, please contact your child's current campus.
