The Nicholas County Board of Education of the County of Nicholas, West Virginia met in regular session on Monday, December 19, 2016, beginning at 7:00 p.m. The meeting was held at the Office of Nicholas County Schools, 400 Old Main Drive, Summersville, WV 26651. 1. Call to Order along with a moment of reflection

The meeting was called to order by Board President, Dr. Gus Penix. President Dr. Penix requested the board approve adjustments to the agenda. The adjustments included; changing *item 4 Discussion* position to be after *Reports* and requested an executive session for the item; to add a bus request and a student transfer request to *Consent*; and add an item under *Finance*.

Mr. Phil Berry moved to adjust the agenda as recommended by President Dr. Penix. The motion was seconded by Mr. Darrell White and carried unanimously.

2. Approve the minutes from: August 23, 2016.

Upon motion by Mr. Darrell White, seconded by Mr. A.J. Rogers, the board unanimously consented to approve the minutes as presented.

President Dr. Penix stated that he would like to clarify some statements; "It is important to understand the structure the NCBOE is working through with FEMA in the flood recovery process. The WV School Building Authority is the direct grantee and recipient of FEMA funding for the demolition and reconstruction of all schools damaged in the June 23rd flood, both in Kanawha and Nicholas Counties. The WV School Building Authority is the state agency responsible for making sure that all state and federal requirements are met in the construction of new school facilities. In the flood recovery process, the SBA is responsible for maximizing monies received from FEMA for relocation and replacement of schools. Further, the SBA is also responsible for assuring that all funds are properly expended according to state and federal guidelines. State law requires that all federal funding for school construction must go through the WV School Building Authority. However, the State of WV Office of Homeland Security, nor the WV SBA will make the final determination of how Nicholas County Schools will be configured in the future. That decision rests solely with the Nicholas County Board of Education.

It has been stated several times, that the Board should hire a consultant. If the NCBOE chooses to hire a consultant, the cost would be totally on the county and would not be reimbursed by FEMA.

Next, as I stated during our November 30 meeting, we are now in Phase 3 of the flood recovery process. Phase 3 involves determining the permanent construction for schools affected by the June 23rd flood.

The Board's decisions regarding Phase 3 must consider evaluation of recommended sites (availability, feasibility, and infrastructure needs), as well as, consider studies of population demographics, student enrollment estimates and economic projections for Nicholas County. This data will guide the Board in making informed decisions about how to best meet the educational needs of all Nicholas County students for decades to come.

The Board must further be in compliance with policies and guidelines of FEMA the WV Board of Education and the WV School Building Authority, as well as, the Board must determine best use of funds provided by the federal and state governments to complete the projects. It is my belief, that this board is committed to making these decisions based on its commitment to providing the best educational opportunities for all 3,800 students in our school system, and preparing all students to be career and college ready when they graduate.

Finally, during three of the past four BOE meetings, this Board has provided opportunity for the public to present information regarding their perspectives on the future of Nicholas County Schools. During those meetings we heard from better than 20 of our citizens, with the word consolidation being mentioned numerous times, both for and against. The NCBOE has had no discussions regarding the final outcome of Phase 3. At our last meeting the Board directed the Superintendent to review the school district's CEFP and propose to the Board for discussion at a future meeting, any amendment or amendments to the CEFP that the Superintendent believes the Board should consider. At a meeting scheduled for Monday, January 9, 2017, here at the BOE office, the Superintendent will present any amendment or amendments she wishes the Board to consider and the Board will publically discuss her recommendations at that time. The Board will then vote to do one of the following: accept her recommendation, reject it, or amend it. That is the process that we will follow. It is transparent and open as required for all WV governmental meetings."

RESA 4 Regional Council Meeting Report ~ AJ Rogers

Nicholas County Board of Education RESA 4 Representative Mr. A.J. Rogers reported to the Board that several Innovation Zone schools had been approved, but that Nicholas County wasn't one of them. He said that some counties are being reevaluated and hopes that Nicholas County is included. He said they were told that not action would be taken on replacing the State Superintendent until after the first of the year and that Dr. Martiano would be there until June 30, 2017.

9. Discussion

Mr. Fred Amick moved to close the regular session and go into executive session as indicated under the authority of WV Code §6-9A-4b-2A to discuss the superintendent's employment contract which ends on June 30, 2017. The motion was seconded by Phil Berry and carried unanimously. The session began at 7:55 p.m.

10. Superintendent's Information:

Superintendent Donna Burge-Tetrick updated the board on maintenance issues at NCHS. She said that 80% of the roof had been replaced, but that now the other 20% has started leaking. She explained that one of the roof top units on the auditorium had gone bad, but that it had been replaced. She also talked about the sewage odor in NCHS being caused by faulty drains. She said that problem had pretty much been alleviated. She said another issue was intentional clogging of toilets. She has asked student leaders to work with other students to try to eliminate this problem.

She also talked about the gray water leak issue at the Beaver property. She said they are working on getting that dried up and then we will put down a vapor barrier. Another problem at Beaver is the boiler. She said maintenance will be done on that over the break.

She informed the board that air quality test done at NCHS and the Beaver property had come back reporting no toxins.

She said that if there are no objections by board members pay checks will no longer be delivered to the schools. Employees have a choice of direct deposit, having their check mailed or picking them up at the board office.
