The Nicholas County Board of Education values in-person learning for all students while ensuring the safety of staff, students, parents, and the community. The Nicholas County Board of Education must set the 2021 reentry plan in accordance with a directive from the West Virginia Board of Education and collaboration with the Nicholas County Health Department.

Beginning **Monday, March 1**, 2021, <u>*ALL*</u> students who opted for <u>in person</u> instruction, will attend school 4 days per week, (Monday, Tuesday, Thursday, and Friday) with distance learning on Wednesdays.

If Nicholas County moves to **RED** on the **WVDHHR County Alert Map** posted each day at 10 a.m., Nicholas County Schools will operate under "**CODE RED**" beginning the next school day:

- ELEMENTARY & MIDDLE SCHOOL STUDENTS will remain on the 4 day per week schedule regardless of the color on the WVDHHR County Alert Map.
- HIGH SCHOOL STUDENTS transition to fully remote learning and will remain remote until the next Saturday's WVDHHR County Alert Map for Nicholas County.

Fulltime distant and virtual students will continue to do assignments regardless of county status on the WVDHHR Alert Map.

Pre-k students will remain on the A & B schedule.

Staff and students at all grade levels will wear face coverings.
