Board President Penix asked Dr. Tetrick to verify the information regarding the boundaries with Zela and Birch River Elementary Schools. Dr. Tetrick explained that the board had given her permission to explore changing the boundaries. Both schools were holding an open house with discussions on the changes to see if there is enough public support to change it. Parents will also have the choice of staying at current school or moving if the boundaries are changed. Again, this is being explored at this time, no changes have been made, nor will they until the board is updated and vote on the subject.

Superintendent Burge-Tetrick updated the board on a statement that had been brought to her attention regarding House of Delegates member Caleb Hanna. According to multiple people, Delegate Hanna made the statement on numerous occasions that the NCBOE was corrupt, a "real mess", and couldn't be trusted with finances. Board members agreed with Dr. Tetrick "that it is very bothersome that this new delegate would make such a statement without just cause."

Mr. A.J. Rogers made the motion that the Superintendent draft a letter to Delegate Hanshaw and Delegate Hamrick for an explanation as to why the statement was made at a House Education Committee meeting, the motion was second by Mr. Fred Amick and carried unanimously.

While in the board meeting, Dr. Tetrick received word that the Nicholas County teachers and service personnel had voted by a margin of 94% to participate in a work stoppage if one was called statewide. The work stoppage was called before the board meeting ended.

Mr. Fred Amick along with the entire board extended their appreciation to Mr. Tom Bayless and all that helped at the Nicholas County Career and Technical Center for making the Glenville State College partnership celebration such a success.
