1. Call to Order:

The meeting was called to order by Board President, Dr. Gus Penix.

2. Approve minutes of meeting held on July 8, 2016.

Upon motion by Mr. Darrell White, seconded by Mr. Fred Amick, the board unanimously consented to approve the minutes as presented.

- 3. Discussion:
 - a. Nicholas County Schools new logo
 - b. ZMM ~ Steve Hendrick, Marie McCauley and Dave Ferguson presented the board with an updated report on the structure inspection of SMS and RMS. According to the report on SMS rooms 101 & 102 had multiple cracks worse than in the remaining part of the building. The estimated cost of repairing/rebuilding the outside walls (80 ft.) was \$300 to \$500,000.00. According to the report, ZMM recommends that those rooms should not be used.

The report on RMS; the building has significant damage in the area of the art room, outside of the guidance counselors office and in that general area. Several stair step cracks were found on the load bearing walls. According to the report, ZMM recommends that those areas should not be used. The estimated cost was \$1 to 1.4 million dollars in repairs.

b. Super Scholar Program

Board members asked that each school follow the same guidelines as was set when the program started unless it is updated before school starts. Teachers,

parents and students need to be informed of the guidelines at the beginning of school.

4. Delegation:

Mr. John Kessler spoke before the board asking that the board continue to support RMS and not to consider closing the school. He volunteered to assist in any way that he could help.

Mr. Greg James spoke on behave of RMS and RHS asking that the board continue the support and not consider closing the school.

Mayor Bob Henry Baber of Richwood spoke to the board and the attending citizens. He commended the board members and asked that the residents be patient until FEMA and all involved had time to receive the reports.
