The Nicholas County Board of Education of the County of Nicholas, West Virginia met in regular session on Monday, October 17, 2016, beginning at 7:00 p.m. The meeting was held at the Nicholas County Board Office, 400 Old Main Drive, Summersville, WV 26651. The purpose of the meeting was to conduct routine business.

1. Call to Order:

The meeting was called to order by Board President, Dr. Gus Penix.

2. Conduct Student Disciplinary Hearings Cancelled

3. Approve the agenda:

Upon motion by Mr. Fred Amick, seconded by Mr. Darrell White the board unanimously consented to approve the amended agenda. Added, item (e) Contract with Goldman Associates (Dixie Property).

4. Delegation:

Tammy Coleman came before the board representing The Chamber of Commerce / Municipal Planning Commission / City of Richwood / Richwood Building Commission / Richwood Fire Department / Economic Development Committee and the Incident Command Team with a proposal of where to locate the combined Richwood High School and Middle School.

5. Approve the minutes from September 26, 2017.

Upon motion by Mr. Darrell White, seconded by Mr. A. J. Rogers the board unanimously consented to approve the minutes as presented.

5. Recognition:

a. Mark Osborne, Chuck Rose, & Peaches Stephenson

Dr. Donna Burge-Tetrick presented each of the drivers with a Good Samaritan Certificate for the lifesaving efforts provided to a citizen in need of medical help.

b. Robin Sizemore with The Council of State Science Supervisors (CSSS) ~ donation of \$2,994.38 to Richwood High School science department.

Mrs. Sizemore from the State Dept. of Education presented a check in the amount of \$2,994.38 to Mr. Scott Williams, Principal of RHS along with the head of the Science Dept.

6. Discussion:

a. Truancy Diversion Program update ~ Mike Williams, & Rebecca Groves.

Ms. Rebecca Groves came before the board to give an update on the Truancy Diversion Program. Year to date there has been 72 letters sent home.

b. Attendance update and reimagining time proposal.

Ms. Vickie Nutter gave an update on the Elementary attendance and the fact that the goal is to reduce the number of students put on probation.

She also made a presentation to the board on the new program called Reimagining Time. This will be a "snow packet" program. Our proposed County title for the program will be called "Summer Saver Days". This program should save (5) five days at the end of the calendar for snow days.

c. Cindy Whitlock, School Health Director with New River Health.

Ms. Whitlock spoke with the board on all that New River Health has done over the years for not only our students but our employees.

d. Update on 2016 General Summative Assessment Results Data by School Lydia Young, Susan Barrett, and Tammi Gregory.

Ms. Young explained that grades 3-11 take the English/Language Arts, and Math tests. Grades 4, 6 and 10 take the Science exam. Nicholas County 5th grade students scored above average in the state. However grade 10 was below the state average.

- e. Tony Nichols Federal Programs:
 - 1. After School ~ Mr. Tony Nichols explained how the Extended Learning program works and in what schools it will be in this school year. There will be six weeks of instruction in the Fall and again in the Spring.

2. Interventionists ~ Mr. Nichols, Susan Barrett and Tammi Gregory explained how the federal programs department supports all the interventionist positions. Also gave a report on how the instruction is given. Title I ~ Academic Intervention: 3 at BRE, 3-CRE, 4-GRE, 2-MLE and 2-Zela. Title II ~ Academic Intervention: 1 – GCE, 1-MNE, 1-PCE and 1 at SES. Title VI ~ Graduation, Truancy, & Drop Out Prevention: 1 at SMS, 1-RHS, 1-NCHS and RMS (title I funded). He stated that most are retired teachers that participate in the program, working 420 hours per year (17.5 hours per week).

3. Professional Development:

Susan Barrett along with Nichols and Gregory gave an update on the Math Professional Development that has been being taught over the past few weeks. There have been 97 teachers attend this program.

Mr. Nichols brought attention to the number of students that participated in the County Literature Fair this year. Every school was represented and there were 140 projects on display. Congratulations to each child that participated.

f. Flood Recovery:

1. SMS, RHS, RMS portables:

Dr. Tetrick announced that ground had been broken for the SMS portable classrooms. Estimated date for move in is December 5, 2016. She also told the board that storage units were needed due to the fact that the SMS building is unsafe.

2. Permanent Site Proposals:

Dr. Tetrick gave the results of the survey for permanent sites: there were 350 total surveys completed. The results varied between Craigsville, Richwood Dillard Farm and the Business Park at Glade Creek.

Per Board President, Dr. Gus Penix: "The Board of Education is moving into Phase 3 of the flood recovery process resulting from the June 23rd flood. Phase 3 deals with permanently locating, configuring, and designing new school facilities. As of this date, the Board has made no decisions, nor is the board predisposed to any final outcomes regarding these matters. Decisions will be based upon the following Board commitments: providing the best educational opportunities for all 3, 822 students in our school system, and preparing all students to be college and career ready when they graduate.

The Board's decisions regarding Phase 3 will impact the education of Nicholas county students for many years to come. Thus, final outcomes for this phase must consider: (1) evaluation of recommended sites (availability, feasibility, and infrastructure needs); (2) studies of population demographics, student enrollment estimates, and economic projections for Nicholas County; (3) compliance with

policies and guidelines of the Federal Emergency Management Agency (FEMA), the WV Board of Education, and the WV School Building Authority (SBA); and (4) best use of funds provided by the federal and state governments to complete the projects.

Again, as of this date, the Board has made no decisions, nor is the board predisposed to any final outcomes regarding the locating, configuring, and designing of new school facilities as a result of the June 23rd flood."

g. Comprehensive Behavioral Health Plan for Nicholas County Schools.

Superintendent Tetrick explained the proposed Comprehensive Behavioral Health Plan that she and School Physiologist Rachael Hendricks are working on. The County is in need of having a Behavioral plan to help not only our students but our teachers.
