

**Resolution of the Board to Set Tax Rate**  
**(If Total Maintenance and Operations Revenue Will Exceed Previous Year)**

On this date, we, the Board of Trustees of the Muleshoe Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2021-2022 at a total tax rate of \$1.2383, to be assessed and collected by the duly specified assessor and collector as follows:

\$1.0437 for the purpose of maintenance and operations, and

\$0.1946 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THOUGH THE MULESHOE ISD BOARD OF TRUSTEES DID NOT INCREASE THE TAX RATE, THE TAX RATE WILL EFFECTIVELY BE RAISED BY 1.75 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$21.30.**
