Holyoke School District Re-1J Board of Education Resolution to Declare a Vacancy (Board Member Resignation) BE IT RESOLVED that, the Board of Education of Holyoke School District Re-1J accepts the written resignation of Jill Herr from the Board of Education effective March 2, 2023; and

BE IT RESOLVED that, in accordance with state law, the Board now declares a vacancy in this school director office on this date, March 2, 2023, and this vacancy will be filled by appointment by the Board within 60 days from this date in accordance with the following procedure:

- Interested persons are invited to pick up an application at the Holyoke School District Administration Building located at 435 S. Morlan Avenue in Holyoke, CO. Applications are due to the same location by 2:00pm on April 11, 2023.
- 2. The Board will interview prospective candidates on April 18, 2023 at a public meeting.
- 3. To be eligible for appointment, a candidate must be a registered elector of the school district for at least twelve consecutive months prior to the date of appointment and must not have been convicted of a sexual offense against a child. C.R.S. 22-31-107(1), (5). Each candidate for appointment to the vacancy shall establish their eligibility to hold office by submitting a sworn affidavit attesting to their qualifications for office by 2:00pm on April 11, 2023
- 4. The appointee will serve until the next regular school biennial election in November 2023.
