### **ATTENDANCE**

Students who attend school consistently and are on time, develop better socially, establish better communications with their teachers, acquire important lifetime habits such as dependability, self-sufficiency, and responsibility and have more success academically. The chart below shows the impact of missing a few minutes to a few days a week on a student's education.

One or two days a week does not seem like much but . . .

On Monday, school starts at 8:35 a.m. On Tuesday, Wednesday, Thursday and Friday, school starts at 7:45 a.m. Students are expected to be at school every day. Students are also expected to be on time to school **AND** classes. If your student will not be at school, please call 574-269-7211 before 8:15 a.m. to notify us why he/she will not be at school that day.

# **School Arrival**

On Monday, school doors will open at 8:20 a.m. On Tuesday, Wednesday, Thursday and Friday, school doors will be open to students at 7:25 a.m. It is strongly recommended that the student regulate his/her time so that he/she does not arrive before this time. Students arriving by automobile should follow the appropriate traffic patterns and use the designated drop-off and pick-up sites for their school. Once students have entered school grounds, they are not permitted to leave until the end of the school day unless a parent/guardian picks the student checks them out through the office.

# **Leaving School Early**

If a student is to leave the building during school hours, he/she must:

- Bring a written note signed by parents explaining the reason for leaving.
- Get permission from the main office before school to receive a checkout pass for the appropriate time.
- Sign out in the main office using the Raptor system.
- If a student returns to the building, they will need to sign in using the Raptor system.
- Bring back a doctor's slip, if applicable, stating an office visit was made.

# **School Dismissal**

Students are to leave the school building in an orderly and safe manner. Students are not to be in their assigned building or on grounds, or any other school building or grounds, after school unless under supervision of an adult sponsor. Dismissal time will be 2:55 p.m.

#### **BREAKFAST**

All Lakeview students receives a free breakfast. If a student chooses to get a breakfast, they will get in line when they enter the building. Once they have received their breakfast, they will immediately report to their first class of the day. This is the same policy as last year. Students **WILL NOT** eat breakfast in the cafeteria.

Students that do not choose to get a breakfast should report directly to their first class of the day. Responsible students report immediately to their first class of the day.

# CELL PHONE PROCEDURES FOR WCS MIDDLE SCHOOLS (IMPORTANT)

Students may have their cell phone with them but should turn it off and put it away once they enter the building. They may begin using it again once the bell rings to conclude the school day. Any phone that is being used during the school day will be confiscated and turned in to the office. The student may pick their phone up in the office after the bell rings to conclude the school day. Students violating this policy will be subject to disciplinary action.

The loss or theft of cell phone or other personal electronic device will not result in an investigation by school administration.

# **DRESS POLICY**

Neat and well-dressed students contribute greatly to the image that a school presents to the public. Students who recognize their responsibility to this situation will lend their cooperation and support to projecting an acceptable image of themselves, to each other and to the community.

All students shall be groomed and dressed in a safe, clean, and non-disruptive manner while attending school or school-sponsored activities. A student's dress or appearance shall not present a danger to the student's own health and/or safety or to that of others. The wearing of shoes at all times is considered appropriate in accomplishing this objective. Dress, wearing apparel, and accessories shall not interfere with classroom procedures or be disruptive to the orderly routine of the school program. The school assumes that parents will accept responsibility for having their students appear in an acceptable manner that will contribute to a desirable school image.

Examples of improper attire or appearance that are not acceptable for school or school-sponsored events:

- 1. Articles of clothing or jewelry that bears the name of, advertises, or advocates the use of any tobacco or alcohol product or any other drug.
- 2. Articles of clothing which have objectionable words or illustrations.
- 3. Articles of clothing that gather undo attention, or are disruptive in any way to the educational process.

These include

- a. Low-cut tops which are too revealing.
- b. Clothing that exposes the torso or belly.
- c. See-through fabrics.

- d. Shorts, skirts and dresses that **do not extend past** the student's fingertips. A "walking test" may also be used to determine appropriateness.
- e. Athletic shorts that are shorter than fingertip length and pajama pants.
- f. Leggings are permitted with tunic-type/longer shirts.
- g. Clothing worn at an inappropriate waist level. Students will be required to wear their pants pulled up appropriately.
- h. Tops with cuts, holes, or tears anywhere on them; bottoms with cuts, holes, or tears that are above fingertip length.
- i. Dresses or tops with thin straps (examples include tank tops). Straps must be **at least 2 inches wide on shoulders**. A good way to measure straps is to use the Student ID or a debit/credit card. Straps must be wider than the short side of the ID or debit/credit card.
- j. Clothing that makes undergarments visible.
- 4. Footwear that does not cover and protect the bottom of the foot or that becomes easily detached from the foot during normal school activities.
- 5. Hats, coats, and jackets designed as outerwear worn inside the building during the course of the school day.
- 6. Dress, grooming, and/or apparel that leads school officials to reasonably believe the student is involved in, associated with, or displaying for the purposes of membership, the symbols, or trademarks of a gang or other groups which initiate, advocate or promote activities which threaten the safety or well-being of persons or property on school grounds or which disrupt the school environment or the educational process.
- 7. Extreme hairstyles or colors that cause disruption to the educational process.
- 8. Jewelry that draws undue attention or that could produce injury to others or oneself.
- 9. Dark or colored glasses as well as sunglasses should be worn outside, unless prescribed by a physician or optometrist.

The administration reserves the right to initiate disciplinary action when in its opinion the Student's dress or appearance is responsible for a disturbance, is leading to disruption, or represents a hazard to health or safety.

#### **ID BADGES**

All Lakeview students will be issued ID badges. Students are not to deface the card. Unusable cards need to be replaced at the Student's expense immediately. The identification badge is to be attached to the school-issued lanyard to be worn around the student's neck at all times. *Students are expected to wear their ID badges every day*. ID badges will also be used in the library for checking out materials. ID badges give students certain perks including buying "extra's" or alecarte items at lunch and eating outside in the courtyard.

# New for the 2022-23 School Year:

In an effort to promote continuity, consistency, and uniformity at Lakeview Middle School amongst all our diverse course offerings, new procedures will be put in place in regards to grading, missing work, late work, and homework for the 2022-23 school year. These procedures have been put in place ultimately to benefit our student body. Exceptions may apply to courses that are required for high school credit.

# GRADING PERCENTAGE BREAKDOWN PROCEDURES

The grading procedures at Lakeview Middle School will be based on a weighted model where assessments, projects, and major writing assignments will make up 75% of the students' final grade per quarter. A minimum of three assessment grades will be entered by the teacher per nine weeks. Teachers will have the autonomy to decide which assignments figure into the "assessment" category and will focus on student mastery of the essential grade level academic standards. At a minimum, teachers must allow one retake per assessment grade entry. Homework and classwork will be worth 25% of students' final grade per quarter. More information about classwork and homework procedures will be found in the section below.

# LATEWORK, MISSING WORK, AND GRADE SUBMISSION PROCEDURES

All homework and classwork are due within five school days of the due date assigned. All homework/classwork that is turned in late will be subject to a 10% grade deduction. After that, assignments will be marked as a zero in Power School. Teachers will be required to enter at least one grade per week into Power School and will be encouraged to grade assignments in a timely manner. (If at all possible within a week time frame.)

Again, these important procedural changes are an attempt to better serve our student body. We want students' final grades to be representative of mastering essential grade level standards.
