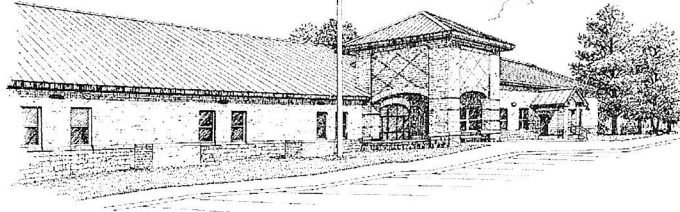

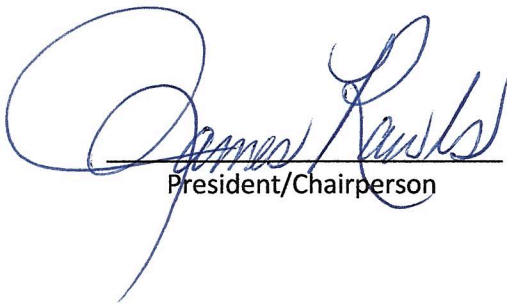

2. At 6:00pm a motion was made by Steve Ivy, seconded by Alan Ferguson to approve the minutes from the Regular Board Meeting held on Tuesday, October 8, 2019. The motion passed 4-0 at 6:01pm.
3. At 6:02pm a motion was made by Alan Ferguson, seconded by Brandon Evans to approve the financial report as presented by Jimmy Cunningham. The motion passed 4-0.

5. At 6:11pm a motion was made by Steve Ivy, seconded by Brandon Evans to amend the School Improvement Plan to move Literacy from a #5 priority to a #1 priority. The motion passed 4-0.
6. At 6:11pm Shelly Sawyer and Angela Newton gave a presentation and report on literacy improvement for K-6.
