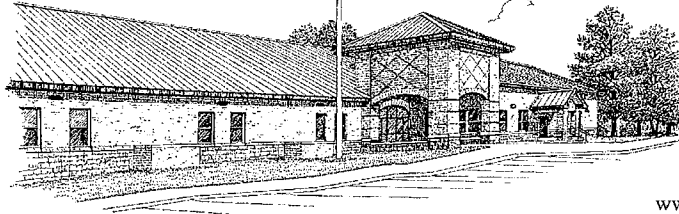




1. Meeting was called to order at 6:30pm by Cody Ables.
