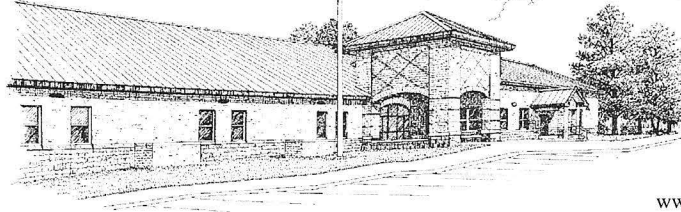



- High School – Desmond Brown


