DISTRICT RETURN TO SCHOOL PLAN 2021

WEEKLY SCHEDULE

- In-person instruction 5 days per week for all students in grades 5K-12.
- The first day of classes for 4K students will be TUESDAY, SEPT. 7TH. They will attend school all day on their assigned attendance days. Fridays will be family outreach days for 4K.

TRANSPORTATION PLAN

- The district must follow the federal transportation guidelines. Currently, masks are required on buses until January 18, 2022.
- It is recommended that family members sit together on the bus.
- Parents are encouraged to maintain a consistent bus riding schedule.

STUDENT MEAL PLANS

- Breakfast and Lunch will be free for all students attending school in the School District of Greenwood during the 2021-22 school year.
- Specific cafeteria protocols for the elementary and high school will be communicated to students by the individual schools.

DAILY OPERATION PLAN

- A daily self-screening symptom checklist will be sent to all families, students, and staff. No one should come to school if the symptoms checklist indicates the student or staff member should remain home.
- Masks are highly recommended for all students and staff by the CDC. Masks are not required.
 Masks will be available in the school buildings and on buses.
- If 5% of the total student population become positive for Covid at any one time, a Special Board meeting will be called to discuss if a change in protocols is in order.
- The district will continue to limit non-essential visitors during school hours. Any approved visitors must follow all district safety protocols.

PHYSICAL SPACES PLAN

- The district will look to maintain a minimum of three (3) feet of physical distancing to the greatest extent practicable.
- Barriers will be used in public spaces where advisable or requested.
- Safety signage for hand hygiene, protective measures and symptoms awareness will be displayed throughout the buildings.
- Bottle filling stations are available throughout the buildings. Students may bring their own water bottle.

HEALTHY ENVIRONMENTS PLAN

- The district has established daily and weekly protocols for cleaning and disinfecting.
- Staff will continue to reinforce safety protocols.

POINTS OF CONTACT REGARDING COVID-19

- Points of contact for any COVID-19 issues involving students or staff are Mr. Green and Mr. Felhofer.
- The district will NOT be participating in the State of Wisconsin's CVID-19: K-12 School Testing Program. Parents should contact their health care provider or the Clark County Health Department regarding Covid-19 testing options.

POSITIVE CASE ISOLATION (PER CLARK COUNTY HEALTH DEPARTMENT 8/17/21)

- Individuals (unvaccinated and vaccinated) testing positive will be required to isolate for 10 days from the onset of symptoms or positive test and must be symptom free for 24 hours without medication before returning to school.
- Individuals with 2 or more Covid-19 related symptoms will need to be sent home.

CLOSE CONTACT QUARANTINES (PER CLARK COUNTY HEALTH DEPARTMENT 8/17/21)

- Individuals identified as close contacts who are not fully vaccinated will be required to quarantine for 14 days. Quarantined individuals must be excluded from in-person classes and extra-curricular activities. The 7-day and 10-day shortened quarantines are NOT options, because we cannot guarantee 6-foot physical distancing throughout the day or mask wearing by all persons in the buildings.
- Asymptomatic close contacts who are fully vaccinated will NOT be required to quarantine. It is recommended they test 3-5 days after exposure (and if universal masking requirements are NOT in place, they should wear a mask for 14 days, unless they test negative).

DAILY SCHEDULES FOR GRADES 5K - 12

- Grades 4K 6: 8:00 a.m. to 3:10 p.m.
- Grades 7 12: 8:00 a.m. to 3:20 p.m.
- Doors to enter school buildings will open for students at 7:40 a.m. each day.

REMOTE LEARNING OPTION 2021-2022

• If a family wants a remote learning option for the 2021-2022 school year, they must register for classes through the Rural Virtual Academy. Please contact the building principals for more information.

CO-CURRICULAR ACTIVITIES

- The CDC & WIAA highly recommend that any co-curricular participants wear a mask.
- Greenwood will abide by WIAA and the Cloverbelt Conference guidelines.
- Masks are highly recommended for all spectators at all co-curricular events.
- As many school events as possible will be live-streamed.
