

Ready to Achieve 2021-2022 For Students

Our schools and district leaders have been working on detailed plans for reopening schools and providing educational services this fall using the Louisiana Department of Education's Guidelines updated on August 11, 2021. Lincoln Parish School Board will work diligently to help our students and employees remain safe throughout this pandemic. Together, we are Ready to Achieve in Lincoln Parish.

School Facilities

- School facilities have received a thorough cleaning in preparation for the return of teachers and students.
- High traffic areas and high touch areas in classrooms and facilities will be cleaned minimally twice during the school day. Crowds will be minimized at entryways.
- Water fountains may only be used to fill water bottles or cups.
- An isolation area will be designated at each school site for students who are ill.
- Each school will be assigned a school nurse.
- Contact tracing will continue at each school.
- Field Trips (STEM only) may be available later this fall.
- \bullet Open Houses and Prep Days Masks are required for all adults and students K 12.
- Athletic events Masks are required for indoor events.

School Buses

- Masks are required for all students and adults while traveling on a school bus. This
 includes traveling to and from school, athletic events, etc.
- All students must be wearing masks when getting on the bus and keep them on until they exit the bus.
- School buses will be disinfected regularly and scheduled cleaning protocols will be in place.
- Seating charts will be maintained by bus operators to aid in contact tracing as needed.
- Windows will remain down unless it presents as a safety or health hazard.

Meals

- Food Service protocols may vary by school and grade level. Each school will determine the best procedures based on school context.
- Cafeteria tables will be used with students sitting in their static groups or sitting on the same side of the table.
- Breakfast options will include a grab-and-go OR a hot meal, and all meals are free to students.
- All schools are encouraged to get parents to submit applications online or in print for Free and Reduced Meals. This should be done as soon as possible for qualifying pandemic funding for families.
- Water fountains in the cafeteria may only be used to fill water bottles or cups.

Students

- Instruction will be in-person unless a student meets the criteria for temporary homebound services. (Medical documentation is required and must accompany the application.)
- Masks are required for all students in grades K-12
- Students will be required to wash their hands and sanitize often during the day.
- Social distancing to the greatest extent possible is recommended.
- No masks are recommended when students are outside.
- Mask breaks are recommended throughout the day at the teacher's discretion.
- Students should bring a water bottle with water to drink during the day. Water fountains will be open to refill students' water bottles. However, students may not drink from the spout.
- Students will be responsible for missed work when absent, quarantined due to exposure, or isolating to testing positive, and should access their teachers' Google Classrooms for information.

Visitors on School Campuses

- All visitors will wear masks while on campus, and only essential visitors should be permitted on campus. Essential visitors are defined as being on campus to conduct observations, interventions, in-district special education services, in-district mental health consultations, etc.
- Unfortunately, visitors are not permitted on campus to eat lunch, volunteer, etc. at this time. We are hopeful these guidelines will change soon.

When to Stay Home

- Students who are ill should stay home regardless of symptoms. *
- All covid-19 symptoms should be monitored closely.*
- Fever of 100.4 requires students to stay home or be picked up from school.*
- Unvaccinated students must quarantine at home if they are exposed to Covid-19. *
- Vaccinated students are not required to quarantine at home if they are exposed -UNLESS they become symptomatic.

Quarantine Requirements for Students Who are Exposed to Covid-19

- Close contacts will be considered as unvaccinated and unmasked students who are exposed to a positive Covid-19 case of closer than 6 feet for 15 cumulative minutes over a 24 hour period.
- Properly masked students are not required to quarantine unless symptomatic.
- Close contacts will be required to quarantine at home for 10 days unless a student receives a negative covid-19 test on or after day 5, at which time the student may return on day 8 after exposure.
- Close contacts will also be considered as any unvaccinated student living in a household in which a positive Covid-19 case is confirmed or suspected.
- A vaccinated student who is exposed to a positive case is not required to quarantine unless symptomatic. Testing on day 5 is recommended but not required.
- Students who have been positive for Covid-19 within 90 days do not quarantine.

Isolation for Students with Positive Covid-19 Test

- Students who test positive for Covid-19 will be required to isolate at home for 10 days from the onset of symptoms and may return after the 10 days if free of fever for 24 hours and symptoms have improved.
- Students who experience Covid-19 symptoms and do not get tested will be required to follow the same guidelines as if they are positive and isolate at home for 10 days from the onset of symptoms. They may return after 10 days of isolation if free of fever and symptoms have improved.
- Students who experience Covid-19 symptoms and test negative may return to school if a doctor has provided an alternate diagnosis.
