Facilities Assessment

RSU 64 App

The District launched the RSU 64 App on August 9, 2021. The app will be used to communicate from the District and school levels. iPhone users need to download the app from the App Store and Android users do the same from Google Play. The app will be used for all emergency notifications and ongoing communications. Parent contacts are migrated directly from the Tyler student information system. Other school community members wishing to receive notifications can continue to sign up through the District website.

Administrator Reports
