## **Explanation**

For the past few years LUSD has been providing a summer school program as follows:

LES has conducted a four week program with two teachers and the computer Lab Assistant. The program has focused on academic intervention in Language Arts and Math.

LHS has offered a four week Independent Study program. Students meet with the instructor 1 day/week to receive and turn in assignments.

Healthy Start has offered and will continue to offer their summer activities three days per week, on Mondays, Tuesdays and Wednesdays beginning on June 25, 2012 and ending on July 18, 2012, with July 4 as a holiday.

In light of our current budget challenges the staffs from all sites have been discussing strategies for reducing expenditures while still meeting the needs of our students.

Subject: Graduation Waiver Request for Students with IEP's

### **Explanation**:

EC 60851 provides local school boards the authority to waive the CAHSEE requirements for students with IEP's (Individual Education Plans) under certain conditions. The conditions are:

- -- the students have taken the CAHSEE with modifications
- --the students have received the equivalent of a passing score on the section of the test taken with modifications

The issue the State is addressing with this waiver is modifications (calculators, for example). For the Board to waive the CAHSEE requirement, the principal must certify that the pupil has:

- (1) an individualized education program adopted pursuant to the federal Individuals with Disabilities Education Act (20 U.S.C. Sec. 1400 et seq.) or a plan adopted pursuant to Section 504 of the federal Rehabilitation Act of 1973 [29 U.S.C. Sec. 794 (a)] in place that requires the accommodations or modifications to be provided to the pupil when taking the high school exit examination.
- (2) sufficient high school level coursework either satisfactorily completed or in progress in a high school level curriculum sufficient to have attained the skills and knowledge otherwise needed to pass the high school exit examination.
- (3) an individual score report for the pupil showing that the pupil has received the equivalent of a passing score on the high school exit examination while using a modification that fundamentally alters what the high school exit examination measures as determined by the State Board of Education.

Principal Dan Regelbrugge certifies that two students identified as students #2012 CAHSEE 1 and 2 have met the conditions listed above.

#### Recommendation

Approve the waiver request of the requirement to pass parts of the CAHSEE on which a modification was used and the equivalent of a passing score was earned for students #2012 CAHSEE 1 and 2.

Subject: Food Service Increase in Breakfast/Lunch Prices

### Explanation:

We need to increase the amount we charge for both breakfast and lunch in order to be in compliance with state and federal procedures and to cover our food service expenses more effectively. We are afforded the opportunity to make gradual increases over the next two years in order to reach the targeted prices of \$1.25 for breakfast and \$2.50 for lunch. Breakfast prices would increase to \$1.00 for the 2012/2013 school year and to \$1.25 for the 2013/2014 school year. Lunch prices would increase to \$2.25 for the 2012/2013 school year and to the final goal of \$2.50 for the 2013/2014 school year.

#### Recommendation:

- 1. I recommend that the board increase the price of breakfast from \$.75 to \$1.00 for 2012/2013 and the price of lunch from \$2.00 to \$2.25 for 2012/2013.
- 2. I recommend that the board continue the increase in breakfast price by \$.25 from \$1.00 to \$1.25 for the 2013/2014 school year and increase the lunch price by \$.25 from \$2.25 to \$2.50 for the 2013/2014 school year.
