EC 48661 Provides for the placement of a Community Day School on a school campus if authorized by the local Board of Education with an appropriate resolution. We moved CDS from the Garden Club location in August of 2006 because it was not financially feasible to remain there any longer. There are not many public or private meeting spaces in rural and remote locations such as Laytonville and those that exist do not have space for a school.

The CDS location is the former Continuation High School building at the old high school campus. CDS students access their building from east of the old campus and Continuation students access their building from west of the old campus and they are separated by buildings and fences.

Resolution #411 provides the findings supporting the relocation. We must annually approve the resolution, unless a suitable off campus facility is obtained in future years.

As discussed during the April 5, 2012 Board meeting, we are hoping to reduce the expenses of our Summer School program. Both school site staffs have discussed how to accommodate the needs of our students while making cost reductions. They have come up with the following scenarios:

LHS will continue offering a four week Independent Study Program in which the students meet with the instructor 1 day per week to receive and turn in assignments. Cost \$2,000.

LES will conduct a four week daily program with one teacher providing academic intervention focused on language arts. Cost \$4,700.

Both programs will run from mid July to mid August. Specific dates to be determined.
