## **REGULAR BOARD OF EDUCATION MEETING**

Tuesday, July 20, 2021 MINUTES

CALL TO ORDER AND ROLL CALL: The meeting was called to order by President Kinsley at 7:00 p.m. Roll call:

**CERTIFICATION OF AGENDA POSTING AND APPROVAL OF AGENDA:** Motion by Olson to certify agenda posting. Olson made a request to move action item #3-employment after Item H-closed session. Second by Bodo. All in favor. Motion carried 6-0.

**APPROVAL OF PREVIOUS MEETING MINUTES:** Kinsley moved to approve June 15, 2021 regular meeting minutes with correction to redact "Kinsley-yes" in the Roll call vote in closed session to move back into open session and June 9, 2021 special meeting minutes. Second by Bodo. All in favor. Motion carried 6-0.

#### **AUDIENCE RECOGNITION:**

Tanya Johnson-community member looked for the board's consideration to donate the existing elementary playground equipment to the Radisson Evangelical Free Church. Discussion was had.

### **ADMINISTRATION AND COMMITTEE REPORTS:**

<u>Principal Report</u>: Zopp has been prepping for the upcoming school year and finishing up on interviewing new staff. In athletics: summer leagues and camps are in session

<u>District Administrator Report</u>: Grimm discussed combining two positions: after-school coordinator and summer school coordinator. Regular summer school will begin August 9th and run through August 12<sup>th</sup> from 8am to noon. Teachers will be reporting on August 16 for their regular week-long inservice. An additional 4 days of summer school will be offered for all students August 23rd through August 26th from 8:10-1:00. Open house will be held on August 19th from 5:30pm to 7:30pm. Tours of the building will be given to show off work that has been completed. Grimm reported that masks are mandated on all public transportation, including school buses and vans. Grimm will be meeting with CESA 10 representatives in September and October to go over long-range facility plans.
