Dear Parent/Guardian,

In keeping with Southwest Schools’ practices to respond to COVID-19, we are notifying all staff and student families with a weekly letter, and you may also access the daily report on our website, www.swschools.org under Superintendent Communication. This report is involving individuals who were/are lab confirmed to have COVID-19. Due to privacy requirements, we will not be releasing the names or identifiable information of the individuals.

The local health department has been notified. Anyone determined to be in close contact with the infected individuals has been notified by their administrative point of contact. Cases will remain on the website report no longer than 10 days from onset of symptoms or the asymptomatic test date.

The facilities have been cleaned and all employees and students are instructed to continue to follow district health guidelines and recommendations and practice social distancing.
