### 5. FINANCIAL REPORT

Mrs. Reisch, Business Manager, said year-to-date, there have been \$5.1 million in expenses and income is at \$5.3 million. She said she is continuing to work on the budget and will be getting more detailed information out in January. Mrs. Reisch discussed the food program and said currently the district is in the red \$22,000. The Colorado Department of Education has approved a cost adjustment for breakfast charges to decrease from \$2.85 to \$2.55 per meal, which Sodexo charges the District. This decrease will help offset the end of year loss. **FINANCIAL REPORT APPROVED AS PRESENTED**

### • Primary School Construction

Superintendent Lovato shared that the RFQ-P is in the process of being completed to solicit architects. He said Mr. Canaday has been in contact with Ms. Honisberg, with the Colorado Department of Education, Capital Construction Regional Program Manager. Superintendent Lovato said that we were under the impression that finding an architect needed to be a competitive process, however, this might not be the case. Superintendent Lovato said would rather complete the interview process and there should be about a six-week turnaround to choose an architect. He said he is hoping for work to begin around spring break, but is not sure it will be complete by the beginning of the 2018-19 school year. Mr. Vela asked how an architect will be selected and Superintendent Lovato said a committee of five will interview and select.

Superintendent Lovato spoke about the 2018-19 calendar. He told the Board the committee met last week and a recommendation for formal approval will be in January. There is an opportunity to provide dental care for some of our students. Kids First Mobile Dental is a mobile dental practice. Superintendent Lovato said the school nurse is looking into this program and he will have her attend the Board meeting next month to answer any questions. Director Leyba asked Superintendent Lovato for clarification regarding the longer day for next school year. Superintendent Lovato said the Junior/Senior High School day would be 7:45 a.m. to 3:45 p.m. and the elementary schools would be 7:50 a.m. to 3:40 p.m. Superintendent Lovato said he is also looking into transportation to maybe shorten the time students spend on the bus.
