## **Setting the Direction** for What's to Come at Winterset CSD

We are off to a great start to the 2021-2022 school year, and I am excited about what lies ahead for our staff and students. While the 2020-2021 school year was challenging in many respects, it did provide us with an opportunity to reflect on what our priorities should be as a district with regards to serving the students and families of Winterset. Over the course of last year we spent a great deal of time discussing what our priorities need to be over the next 3-5 years. Based on those conversations, we have identified 5 key areas that we will be focusing on during that time.

#### CULTURE:

We want our students and staff to create a culture of mutual respect that is grounded in strong relationships. In order to do that we trained all of our staff in Capturing Kids Hearts (CKH) and will continue to support our staff as they work to embed they have learned it? these processes in their classrooms, clubs, and athletic teams. Capturing Kids Hearts is based on the EXCEL model which stands when they already know it? for Engage, eXplore, Communicate, Empower, and Launch. Each letter of the acronym reminds our staff of processes that will help them to have better, more meaningful

conversations with students and their colleagues leading to improved relationships, shared ownership, and mutual respect. Capturing Kids Hearts when implemented with fidelity helps students to develop behaviors that create self-managing groups and teams. Hopefully, you will hear your students talk about this process and how their classes are different, in a good way this year.

## **PROFESSIONAL** LEARNING COMMUNITIES:

The district has been implementing Professional Learning Communities (PLC) for quite a few years and this area will continue to be a focus for us moving forward. All of our teachers within the district are a member of a PLC that meets regularly to collaborate and address 5 fundamental questions;

What do we want students to know and be able to do?

How will we deliver our instruction so that they all can learn it?

How will we know when

#### MTSS:

Each building will be using formative assessment data to identify students who need additional support and to adjust their instruction accordingly to provide students with what they need to be successful both academically and

behaviorally.

We want all of our students to be college AND career ready. In order to do that we need to clearly identify and teach the skills and dispositions that employers need in future employees. Over the next 3-5 years we are planning to scale-up the Husky Ready program that is currently in place at the high school by adding programming at the younger grades beginning with the Junior High this year. We are also working to continue to find innovative ways for our students to get hands-on experience within the community through paid internships, apprenticeships, and other work-based learning opportunities.

We are excited about the direction we have set and look forward to the journey ahead. It's a great time to be a HUSKY!




# IOWA SCHOOL BUS SAFETY REQUIRED STOPPING FOR SCHOOL BUSES

SCENARIO 1: YOU ARE TRAVELING ON A TWO- OR THREE-LANE ROAD

Approaching the bus from the rear: When you see flashing red or amber warning lights, you are not permitted to pass the school bus and should be prepared to stop. Stop behind the school bus when the school bus stops and the stop arm is extended. Stop no closer than 15 feet from the rear of the bus, and remain stopped until the stop arm is retracted and school bus starts moving again. Proceed with caution.

Meeting the bus from the front: When you see amber warning lights flashing you must slow your vehicle to no more than 20 mph and be prepared to stop. Stop in front of the school bus when the school bus stops and its stop arm is extended. Remain stopped until the stop arm is retracted. Proceed with caution.






TWO-LANE HIGHWAY WITH CENTER TURN LANE


THREE-LANE HIGHWAY

SCENARIO 2: YOU ARE TRAVELING ON A ROAD WITH TWO OR MORE LANES IN EACH DIRECTION Approaching the bus from the rear: When approaching from the rear, the rules are the same as for a two- or three- lane road. When you see flashing red or amber warning lights, you are not permitted to pass the school bus and should be prepared to stop. Stop behind the school bus when the school bus stops and its stop arm is extended. Stop no closer than 15 feet from the rear of the bus, and remain stopped until the stop arm is retracted and school bus starts moving again. Proceed with caution.

Meeting the bus from the front: When meeting the bus in one of the opposite two lanes (or more), you do not need to stop, even if the bus has stopped with lights flashing and stop arm out. The bus is not permitted to load or unload children who must cross this type of roadway, unless there are official traffic control devices or law enforcement present. This is the only time you may pass a school bus that is stopped and has its stop arm extended.

# **BUILDING SAFETY MEASURES**

In an effort to maintain a safe environment in our schools, all staff in Winterset will be wearing their staff identification badges while on any Winterset School Campus. Additionally, ALL visitors are expected to check into the office of any school building during regular business hours (7:30 a.m. - 3:30 p.m.) each time they visit the school. Visitors will need their driver's license or state issued identification card

to check in. Our system, LobbyGuard, checks state and national databases for individuals who are on the sex offender list. Once a visitor has been cleared. they will be issued a Visitor Badge. This must be worn at all times while in the building. Our staff will be asking people who do not have a badge to return to the office immediately. While this may be a slight inconvenience, this measure will provide better protection for our students.

If you currently don't have access to the Parent Portal, forms are available online or at your child's school. If you don't have computer access, please contact the District Office at (515) 462-2718.


# STUDENT/PARENT HANDBOOKS



# **5th Grade Band Information Letter**



Hello and welcome to the Band program at Winterset Community Schools! My name is Rachel Poss and I'm the new 5th/6th grade band director. I am so excited to start the adventure of learning an instrument with the 5th grade band! There are many questions that I receive in the initial stages of deciding whether or not to join band. In this letter I will provide answers to some of the more common questions, but if you have questions or concerns not addressed here, PLEASE contact me! Email is the best way to contact me!

Why should my kid be in Band? Why is music important? Beginning band will enrich your child's basic education and help develop greater self-confidence, responsibility, dexterity and self-expression. Participation in band encourages teamwork, self-discipline, cooperation and goal achievement. Plus, playing in the band is fun! It's a lifelong skill that is valuable to communities, colleges and people everywhere.

When will my child have band? Do they miss any class? 5th grade band occurs on days 1, 3, 5 from 2:30-3:10. Every student will also receive one band lesson per 6-day cycle. These band lessons will not occur during core classes; students will be taken from other specials and general music for their band lesson.

**Are concerts required or optional?** Yes, concerts are a required portion of the grade and your child's attendance is mandatory. Concerts are like the final test of Band class, but they are also the culmination of everything we work for in class and are the only chance to show our families and our community the fruit of our efforts in a large-ensemble setting.

**What instruments are in a Concert Band?** Students will be able to choose from the following instruments for 5th grade band: Flute, Clarinet, Alto Saxophone, Trumpet, French Horn, Trombone, Baritone, Tuba, and Percussion.

How do I get an instrument? Our local music stores Rieman Music and Uptempo music provide rent-to-own options at a very reasonable cost. Rieman Music will be in the MS commons from 6pm-8pm on September 14th to assist in the rental process. Please be cautious of any instrument from big box stores such as Amazon, Walmart, etc. These instruments are of very low quality and make learning the instrument much more difficult and in some cases, nearly impossible. Also, most music stores will not repair them. Sometimes you'll be able to find instruments on Facebook Marketplace, Ebay, or Craigslist. Please reach out to me prior to purchasing an instrument from FB, Ebay, and Craigslist. so I can help you decide if it'll be worth purchasing!

We simply cannot afford it. If your son/daughter wishes to be in band but you feel that he or she cannot participate due to financial constraints, PLEASE contact me. The school does have a limited number of school instruments available for such circumstances and we will not exclude a student from participating in Band because of money.

What instrument should my son/ daughter play? Your son/ daughter has also been hearing about the instrument choices in our Exploring Band class. I always recommend that students play an instrument that they think is "cool" with a sound they enjoy that they are excited about. If they start on an instrument they did not pick or are not excited about, it can be very difficult to keep him/her motivated throughout the year or in the years ahead. Certain students are more likely to be successful on specific instruments due to physical features.

But I don't know anything about music or playing an instrument! I won't be able to help my child.

Everyone starts at "square one" and progresses together in band. I am always available for extra help if students (or parents!) feel they need it. Students will be taught the necessary skills step-by-step. Parents' jobs are to help their child establish a regular practice schedule (I recommend at least 15-20 minutes, 5 times a week), and to be supportive and patient no matter WHAT kind of sounds you might hear!

We already have a family instrument. Great! As long as it is one of the instruments in 5th grade band AND it is in good playing condition, you're set! (Beginning band does not have string instruments, guitar or piano.) If you have questions about the condition of your instrument, please take it to one of our local music stores BEFORE the start of band and have it checked out.

I would love to have as many 5th graders in band as possible! You will be amazed at the accomplishments the beginning band students will make in just one year's time. We start off squeaking but we end up playing real music. It IS hard work, but it is rewarding work and it produces skills that can last a lifetime! Please consider having your child participate in this wonderful experience!

## IINFORMATION SENIORS SHOULD KNOW

FAFSA! Students going to college during the 2022-2023 academic year are encouraged to complete the FAFSA beginning October 1, 2021. The tax questions will ask for data from tax year 2020. The deadline will be July 1, 2022

All seniors will need to meet with Mr. Seufert where your individual folder, including transcripts, will be reviewed and updated no later than October 1st. Financial aid will also be covered.

Some of you are already in the process of applying for college. Official Transcripts can be sent anytime. Let Tiffanie in the guidance office know when you have applied, she will send your transcripts to your selected college. Colleges will not accept a transcript from you.

Seniors should be aware of the 21-22 ACT's which will be administered here on September 11th, October 23rd, December 11th, February 12th, April 2nd and June 11th. The deadline has passed for the September test. The deadline for the October test is September 19th without a late fee, or

until October 3rd with a late fee. You must register online for the ACT at www.actstudent.

org Juniors & Seniors! Please pay attention to the morning announcements and weekly emails. Messages concerning college visits and scholarship information will be in the announcements and posted on the guidance page on the school's website as well as the Beacon each month. If you wish to visit with a college or military representative, it must be done during your seminar.

Seniors must be aware of the deadline for applying at certain colleges. Some select colleges have a deadline of Dec 1. Please check in the Guidance center and we will help you find the deadline dates. You are encouraged to visit a college of your choice. Follow the proper procedures as outlined in your student handbook. Get your college visit forms from Mr. Seufert.

BEWARE of scholarship search and financial aid service organizations that charge a fee for service. Much of the information you may be seeking is available at no cost. Check with Mr. Seufert or search for free on the web site www. collegeplanning.org.

## COLLEGE REPRESENTATIVES & VISITS

Juniors and Seniors are encouraged to visit college representatives when they visit our school. Students may visit representatives as many times as needed during Seminar time. Seniors may use up to two (2) days for on-campus visits (Juniors may have 1). Additional days for on-campus college visits are subject to approval by the principal. Students wishing to make an on-campus visit must pick up the proper form from Mr. Seufert two (2) days in advance of the visit. Students must have all of the signatures necessary and their work made up in advance for the visit to be approved. The form must be signed by a college representative during the visit. The form must be returned to the office immediately after the visit. If all the procedures are not followed. the absence will be considered a truancy and the student will receive the appropriate consequence. See Mr. Seufert if you need help

arranging a college visit.

The names of colleges and military representatives are always announced at least a week prior to their visit to our campus. Parents are welcome to attend.

TESTING TESTING TESTING!!! Several tests are given during the fall.

The ACT's are given here in September. October, December, February and April to juniors and seniors planning to attend a four-vear college. These are four, 35-60 minute tests in academic areas of english, mathematics, reading, and science reasoning. Colleges in the Midwest, West and South commonly prefer the ACT's. Students receive four separate scores plus a composite score. Now most schools will accept either the ACT or the SAT I.

The PSAT/NMSQT test will be given on October 13th to high school sophomores and juniors nationwide. We encourage sophomores to take them for practice. The PSAT is a useful indicator of scholastic aptitude as well as the basis of some merit scholarships. Also, the PSAT, administered by the College Board, is the source of some college mailings that you will receive. See Mr. Seufert to sign up for the test, cost is \$18.00.

The Armed Services Vocational Aptitude Battery (ASVAB) Career Exploration Program is a two-part mission: to provide a career exploration service to American youth and provide qualified leads to military recruiters. Participants have no obligation to talk to a military recruiter or enter military service, but students in 11th grade and beyond can use their scores to explore enlistment if they choose. The ASVAB will be given on November 4th, sign up with Mr. Seufert if you are ORG interested.

The Iowa Statewide Assessment of Student Progress (ISASP) is the summative accountability assessment for all lowa students that meets the requirements of the federal Every Student

Succeeds Act (ESSA). The test was developed by Iowa Testing Programs (ITP) at the University of lowa as per the Iowa Legislature (HF 2235) and was first administered in the spring of 2019. The ISASP is aligned to the Iowa Core academic standards and accurately describes student achievement and growth.

Assessments will be administered in the following subjects and grade levels:

Mathematics: Grades

English-Language Arts, including reading and writing: Grades 3–11

Science: Grades 5, 8, and 10


# We're Going Back! EF Tours Returns to Ecuador Summer 2022

# Corporal Punishment, Restraint, and Physical Confinement and Detention

State law forhids district employees from using corporal purishment against any student. Board Policy series 500. Certain actions by district employees are not considered corporal purishment. Additionally, district employees may use "reasonable and necessary force, not designed or intended to cause pain" to do certain things such as prevent harm to persons or property. Employees are provided annual training on this law.

State law also places limits on district employees' abilities to restrain or confine and detain any student. The law limits why, how, where, and for how long a school employee may restrain or confine and detain a child. If a child is restrained or confined and detained, the school must maintain documentation and must provide certain types of notice to the child's parent.

#### Fees.

The district charges fees for certain items, such as technolocytemial. Students whose families meet the income guidelines for free and reduced price lunch, the Family Investment. Program (FIP), transportation assistance under open emulated, or students who are in fuster care are eligible to have their student fees maived or partially waived. Students whose families are experiencing a temporary financial difficulty may be eligible for a temporary waiver of student fees. #### Grievance Procedure

It is the policy of the Winterset Community School District not to discriminate on the basis of race, color, national origin, sex, disability, religion, creed, age (for employment), marital status (for programs), sexual orientation, gender identity and socioeconomic status (for programs) in its educational programs and its employment practices. There is a grievance procedure for processing complaints of discrimination. If you

Students, parents of students, employees, and applicants for employment in the school district have the right to file a formal complaint alleging discrimination. The district has policies and procedures in place to identify and investigate complaints alleging discrimination. If appropriate, the district will take steps to prevent the recurrence of discrimination and to correct its discriminatory effects on the Complainant and others.

A Complainant may attempt to resolve the problem informally by discussing the matter with a building principal or a direct supervisor. However, the Complainant has the right to end the informal process at any time and pursue the formal grievance procedures outlined below. Use of the informal or formal grievance procedure is not a prerequisite to the pursuit of other remedies. Please note that informal processes and procedures are not to be used in certain circumstances (e.g., sexual harassment and sexual assault).

## Filing a Complaint

A Complainant who wishes to avail himself/herself of this grievance procedure may do so by filing a complaint with the equity coordinator. An alternate will be designated in the event it is claimed that the equity coordinator or superintendent committed the alleged discrimination or some other conflict of interest exists. Complaints shall be filed within 5 working days of the event giving rise to the complaint or from the date the Complainant could reasonably become aware of such occurrence. The Complainant will state the nature of the complaint and the remedy requested. The equity coordinator shall assist the Complainant as needed.

# Investigation

Within 15 working days, the equity coordinator will begin the investigation of the complaint or appoint a qualified person to undertake the investigation (hereinafter "equity coordinator"). If the Complainant is under 18 years of age, the equity coordinator shall notify his or her parent(s)/guardian(s) that they may attend investigatory meetings in which the Complainant is involved. The complaint and identity of the Complainant, Respondent, or witnesses will only be disclosed as reasonably necessary in connection with the investigation or as required by law or policy. The investigation may include, but is not limited to the following:

- A request for the Complainant to provide a written statement regarding the nature of the complaint:
- A request for the individual named in the complaint to provide a written statement;

- A request for witnesses identified during the course of the investigation to provide a written statement;
- Interviews of the Complainant, Respondent, or witnesses;
- An opportunity to present witnesses or other relevant information; and
- Review and collection of documentation or information deemed relevant to the investigation.

Within 60 working days, the equity coordinator shall complete the investigation and issue a report with respect to the findings. The equity coordinator shall notify the Complainant and Respondent of the decision within 5 working days of completing the written report. Notification shall be by U.S. mail, first class.

# Decision and Appeal

The complaint is closed after the equity coordinator has issued the report, unless within 5 working days after receiving the decision, either party appeals the decision to the superintendent by making a written request detailing why he/she believes the decision should be reconsidered. The equity coordinator shall promptly forward all materials relative to the complaint and appeal to the superintendent. Within 30 working days, the superintendent shall affirm, reverse, amend the decision, or direct the equity coordinator to gather additional information. The superintendent shall notify the Complainant, Respondent, and the equity coordinator of the decision within 5 working days of the decision. Notification shall be by U.S. mail, first class. The decision of the superintendent shall be final.

#### Handbooks and Board Policies

Each year, students/parents may receive a copy of the student/parent handbook. Handbooks and school board polices are posted on the district nebsite at many printersel £12 ia.us. Parents are strongly encouraged to review the handbook and policies of the Board of Education with their student so that both understand the regulations and expectations of the district for students. Handbooks include many important annual notices and information about policies students and their parents are responsible for knowing and understanding. Ignorance of the contents of the handbooks and the policies of the Board of Education excuses no one from complying with these regulations.

Highly Qualified Teacher/Title 1 Parent Notification The Winteret Community School District ensures that parents will be notified in writing if their child has been assigned, or has been taught by a teacher for four or more consecutive weeks who is not considered highly qualified.

#### Homeless Students

In accordance with 281 IAC Chapter 33, tone. Administrative Code, the Winterset Community School District is required to give written notice to homeless children and families if the district is going to deny access to their educational programs.   similar reason; is living in a motel, holel, trailer park, or
  camping grounds due to the lack of alternative adequate
  accommodations; is living in an emergency or transitional
  sheller; is abandoned in a hospital; or is analiting fuster
  care placement.
- A child or youth who has a primary nightime residence that is a public or private place not designed for or ordinarily used as a regular deeping accommodation for human beings
- A child or youth who is living in a car, park, public quace, abandoned building, substandard housing, but or train station or similar setting, or
- A migratury child or youth who qualifies as homeless because the child or youth is living in circumstances described in paragraphs "1" (though "3" above

## Human Growth and Development

The district provides students with instruction in human growth and development. Depending upon the class, students may have opportunities to download class materials, complete assignments online, participate in classroom moderated blugs, and use the internet for research and more. Because of these expanded capabilities, we offer the opportunity for parents to out children

out of Web use in this manner. We ask that you read the notice below, and only return the form to your school office if you do not agree to the terms within. The form is available at registration or in any school office.

Internet Use Statement — As a parent or legal guardian of a student enrolled in Winterset Community School District, I recognize that in accombance with School Board Policy, my student has access to district-owned and operated computer systems, networks, and the Internet. Some of these systems are interactive in nature, and allow my student to participate in online activities designed to enhance and extend classroom learning opportunities. I understand that his access is delivered under the direct supervision of a leacher or other trained adult employee.

Furthermore, I understand that while the Wintersel Community School District strives to provide protection from all objectionable material found on the Internet, some objectionable material is impossible to filter and may inadvertently be accessed. I, as parent or legal guardian, accept responsibility for guidance of appropriate Internet use as it pertains to the exploration and selection of media and information.

# lowa Concussion Legislation

lona lan requires that students in grades 7—12 who participate in extraounicular interschulastic activities, cheerleading and dance; and their parents/guantians; must sign a copy of the activious/general form and return it to their school.

Students cannot practice or compete in those activities until this form is completed.

In addition, please note this important information from Ional Code Section 280.13C, Brain Injury Policies:

A child must be immediately removed from participation (practice or competition) if his/her coach or a contest official observes signs, symptoms, or behaviors consistent with a concussion or brain injury in an extracurricular interscholastic activity. A child may not participate again until a licensed health care provider trained in the evaluation and management of concussions and other brain injuries has evaluated himther and the student has received written disarance from that person to return to participation.

#### Key definitions:

\*Licensed health care provider\* means a physician, physician assistant, chiroproctor, advanced registered nurse practitioner, nurse, physical therapist, or athletic trainer increased by a broard

"Extracurricular interscholastic activity" means any extracurricular interscholastic activity, contest, or practice, including sports, stance, or cheerleading.

# Level 1 Investigator: Alvase

The district aloes not tolerate employees physically or sexually abusing or harassing students. Students who are physically or sexually abused or harassed by an employee should notify their parents, teacher, principal or another employee. The lowe Department of Education has established a two-step procedure for investigating allegations of physical or sexual abuse of students by employees. That procedure requires the district to designate an independent investigator to bok into the allegations. The district has designated the school nurses: Nicole Anderson (PreK-3), Britany Salton (4-6) and Mackenzie Osborn (7-12) at (515) 462-2718, as Level I investigators.

Physical abuse is a non-accidental physical injury that leaves a mark at least 24 hours after the incident. While employees cannot use physical force to discipline a student, there are times when the use of physical force is appropriate. The times when physical force is appropriate include, but are not limited to, times when it is necessary to stop a disturbance, to obtain a meapon or other dangerous object, for purposes of self-defense or to protect the safety of others, to remove a disruptive student, to protect others from harm, for the protection of property or to protect a student from self-infliction or harm.

Sexual abuse includes, but is not limited to, sexual acts involving a student and intentional sexual behavior as well as sexual harassment. Sexual harassment is unwelcome sexual advances, requests for sexual favors or other verbal or physical conduct of a sexual nature when submission to such conduct is made either implicitly or explicitly a term or condition of the student's education or benefits; submission to or rejection of the conduct is used as the basis for academia decisions affecting that student; or the conduct has the purpose of effect of substantially interfering with a shutent's academic performance by creating an infinitialing, hostile or offersive educational environment.

Notice to Parents Regarding Teacher Qualifications Parents/Guardians in the Winterest Community School District have the right to learn about the following qualifications of their child's teacher, state licensure requirements for the grade level and content areas taught, the current licensing status of your child's teacher, and tracealaureate/graduate certification/flegres. You may also request the qualifications of an instructional paraprofessional who serves your student in a Title 1 program.

# Open Enrollment

loua's open enrollment law allows students residing in one school district to request transfer to another school district upon the parents' request. Students wishing to open enroll to another school district must apply for open enrollment by March 1 of the school year preceding the school year in which they wish to open enroll unless there is good cause. Open enrolled students from low-income families may qualify for transportation assistance. Open enrollment may result in loss of alletic eligibility for students open enrolling. Winterset Community School District will accept students for open enrollment. # Parents' Roles During Emergencies

Providing a safe place for students to learn and grow is one of the most important responsibilities of any school system. Along with school officials, teachers and staff, families play a critical rule in preventing and responding to emergencies. This information is intended to provide parents and guardians with the steps you can take before, during and after an emergency. It is the ABC's of the parent's rule during emergencies.

#### A. Beline

Prevention: The Role of Parents in Keeping Schools Safe — Parents and community members play an important role in keeping our achools safe. You can be our eyes and ears by reporting any issues, concerns or rumons related to safety to district or law enforcement officials. Emergency Help Numbers are posted on the front page of the district website.

You also can help by following and supporting all security measures when you visit one of our school buildings. This includes signing in and out at all school district offices and meaning a visitor's leading at all times while in the building.

Contact Information: Another of the most important steps parents can take prior to an emergency is to ensure contact information is updated regularly in the districts Infinite Campus system. Please regularly update emergency and contact telephone numbers, e-mail addresses and other information with your school to ensure you receive information and updates during emergency situations.

It is also important to review and update information regarding who can legally pick-up your child during an emergency. Once his information is on file, you should ensure that those people are aware they have been listed as your "emergency contacts", and that they may receive messages via phone and/or e-mail during an emergency, weather early out, or other situation.

If your child is on medication, be sure the school has at least a. box-day supply.

Create your own family emergency plan. Develop a family communication plan and have a supply kit to sustain you and your family for two to three days. For tips on hour to prepare a plan go to war bereatlylows.org.

## A. During

In a school emergency, the first instinct of many parents is to pick up the telephone and call their child or school, antifor rush to the school to get their children. But the truth is, this only complicates matters from a safety and security stampoint. Parents too close to an incident often hinder rescue attempts of the police and fire officials on the scene. Calling your child's cell phone may prevent them from hearing important, even life-soving information. Too many parents calling the school also tie up needed phone lines and hinder efforts to communicate. Students will be able to use cell phones if they need immediate assistance and once they are safe.

The best action parents can take in an emergency is to monitor heir phone, e-mail and district website for regular updates and instructions.

- Do not report to your child's school during emergency situations. Law enforcement officials will not allow entry to the school site during a botobon or shelter-in-place.
- Avoid calling the school or the district during the emergency.

Notification and Communication: The district is committed to providing parents and guardians with the talest and most accurate information available. Parents will be asked to monitor official emergency updates at the district's website. In today's world, it is likely students will be testing and calling parents immediately. Be aware that information you receive from your child may not always be accurate; ensure the information you are using is official and comes directly from the Wintersel Community School District.

School Emergency Response Prolocula. A school crisis can lake a number of forms including an environmental event, such as a chemical spill or gas leak, a vesilher emergency, such as a tomado verning; or an intruder in or near the school. The nature of a school crisis dictates whether district officials will put in place a lockdown, shelter-in-place, everuation, or any combination of two of these prolocules, as a means to ensure the safety and wellbeing of students and staff.

When and Why are Statients and Staff Astred to Lockshop, Sheller in Place or Evacuate?

- Lockston A belutour is normally in effect when there
  is a fireal inside the building. Students and staff are
  removed from harms way by having them safely located
  inside secure classrooms or other areas inside the
  building to reduce the risk of being expused to the source
  of potential harm. During lockdowns access to the
  building is prohibited.
- Steller-in-Place Shelter-in-place is instituted when the firmat is outside the building. Students and staff are secured inside a dissertion or other areas inside the building reducing the risk for exposure to inclement weather or other potential harm such as a gas release.
- Execution Evacuations are typically conducted to remove students and staff from harms way by having them sately evacuate the school and reassemble in a more secure location.

If the school building is execusized, how will I be able to locate my child?

Parents will be directed to a specific location where they will be required to show proper identification. At the rewritication site, echool administrators, police and fire officials account for students and provide aide to those who need it immediately. Students are released only to authorized individuals. If you are a non-custodial parent, you must be listed with your child's emergency contact information as a guardian and show proper identification.

#### C. Aller

Monitor your child's behavior and let the school know if you brink counseling or help is needed. Following a school crisis, specially trained school and district crisis learn members and social workers are available to provide counseling and outside referrals to students, staff members and others who may need a

Recovery Plan - Depending on the nature and amount of damage, school maybe moved to a different location. The district will inform parents of any changes.

# Protection of Pupil **Fights** Amendment

The Protection of Pupil Rights Amendment (PPRA), 20 U.S.C. § 1232h, requires Winterset Community Schools to notify you and obtain consent or allow you to opl your child out of participation in certain school activities. These activities include a student survey, analysis, or evaluation that concerns one or more of the following eight areas ("protected information surveys")

- Political affiliations or helicis of the student or student's parent;
- Mental or psychological problems of the student or student's family;
- Sex behavior or attitudes;
- Regal, anti-cocial, self-incrimination, or demeaning behavior;
- Critical appraisals of others with whom respondents have close family relationships;
- Legally recognized privileged relationships, such swith language, abottors. Or ministers;
- Religious practices, affiliations or beliefs of the student or parents; or
- Income, other than as required by last to determine program eligibility.

This requirement also applies to the collection, disclosure or use of student information for marketing purposes ("marketing surveys"), and certain physical exams and screenings.

Following is a schedule of activities requiring parental notice and consent or opt-out for the upcoming school year. This list is not exhaustive and, for surveys and activities schedules after the school years starts, the Wintersel Community Schools will provide parents, within a reasonable period of time prior to the administration of the surveys and activities, notification of the surveys and activities and be provided an opportunity to opt their child out, as well as an opportunity to review the surveys. (Please note that this notice and consenticpt-out transfers from parents to any student who is 18 years old or an emancipaled minor under State law.)

- a. Regal, anti-cocial, self-incriminating, or demeaning behavior;
- b. Critical appraisats of others with whom respondents have close family relationships;
- Legally recognized privileged relationships, such as with language, abotous, or ministers;
- Religious practices, affiliations, or beliefs of the student or parents; or
- e. Income, other than as required by last to determine program eligibility.
- Receive notice and an opportunity to opt a student out of:
  - a. Any other protected information survey regardless of funding.

- b. Any non-emergency, invasive physical exam or screening required as a condition of attendance, administered by the school or its agent, and not necessary to protect the immediate health and safety of a student, except for hearing, vision, or sociosis screenings, or any physical exam or screening permitted or required under state law, and
- c. Activities involving collection, disclusure, or use of personal information obtained from students for marketing or to sell or otherwise distribute the information to others.
- Inspect, upon request and before administration or use
  - a. Protected information curveys of students;
  - b. Instruments used to collect personal information from students for any of the above marketing, sales, or other distribution purposes; and
  - Instructional material used as part of the educational curriculum.

These rights transfer from the parents to a student who is 18 years old or an emancipated minur under state law. Wintersel Community School District will develop and adopt policies, in consultation with parents, regarding these rights, as well as arrangements to protect student privacy in the administration of protected information surveys and the collection, disclosure, or use of personal information for marketing, sales or other distribution purposes. Winterset Community School District will directly notify parents of these policies at least annually at the start of each school year and after any substantive changes.

Wintersel Community School District will also directly notify, such as through U.S. mail, or e-mail, parents of students who are scheduled to participate in the specific activities or surveys noted below and will provide an opportunity for the parent to opt his or her child out of participation of the specific activity or survey. The district will make this notification to parents at the beginning of the school year if the district has identified the specific or approximate dates of the activities or surveys at the time. For surveys and activities scheduled after the school year starts, parents will be provided reasonable notification of the planned activities and surveys listed below and are provided an opportunity to opt their child out of such activities and surveys. Parents will also be provided an opportunity to review any pertinent surveys. Following is a list of the specific activities and surveys covered under this requirement.

- Collection, disclosure, or use of personal information for marketing, sales or other distribution. Administration of any protected information survey not funded in whole or in part of the education department.
- Any non-emergency, invasive physical examination or streening as described above.

# Section 504 - Notice of Rights

Wintersel Community School District does not discriminate in admission or access to, or treatment or employment in, its programs and activities. Section 504 of the 1973 Rehabilitation Act is a non-discrimination statute barring discrimination on the lessis of disability. It is the policy of the district not to discriminate on the basis of disability in its educational programs, activities, or employment policies as required by the Act. The 1973 Rehabilitation Act requires the district to locate, exacuate, and determine if the student is a qualified individual requiring accommodation recessary to provide access to educational programs.

Parents are entitled to the opportunity to review relevant exturational records under the Family Education Rights and Privacy Act (PERPA). The requirements are described in the Board of Education Policy Manual that is available on the districts neboite (www.winterset.k12 ia.us). Parents/guardians disagreeing with the decisions reached by district personnel regarding necessary accommodations for access to the educational program may request a hearing before an impartial hearing officer by notifying the districts' ADA/Section 504 Coordinator. The parent/guardian is entitled to participate in the hearing and to be represented by coursed.

# Student Media Interviews

During the course of the school year, students may be interviewed from time to time by newspaper, television, ratio or other reporters in regard to projects, activities and other school events. This is considered a part of the district's directory information consent policy (Student Records, see below), along with photos, video and other media. If you object to your student being interviewed in this manner, you should read and fill out the district's directory information optical form. To obtain a copy of this form, please contact your school's main office.

Use of Recording Devices in School Buildings and on School Buses- Policy 802.08

District-Owned and Operated Recording Devices

The Winterset Board of Education supports the use of recording devices in District buildings, on school grounds and on District buses used for transportation to and from school as well as for field trips, curricular, or extracurricular events. Recording devices may be used as a means to monitor and maintain order and to help promote a safe environment for students and employees.

Recording devices may be used on school buses and other district vehicles and in public areas of the school buildings. Recording devices will not be placed or be used in bathrooms, shower facilities, locker rooms, or other similar spaces where privacy is reasonably presumed. Determination of how recording devices will be used and which areas of the school will be equipped with recording equipment will be made in consultation with the building principals and Director of Operations.

The contents of the recordings may be used as evidence in student or employee disciplinary proceedings, and also for regular driver training and improvement on an individual or group basis. The content of the recordings may be considered a confidential education record and/or a confidential personnel record. Such records will be handled in accordance with applicable law and Board policies regarding access to and disclosure of student and personnel records. Parents may request to view a recording which is an education record of their child to the extent permitted by law.

#### Notice

The school District will annually provide the following notice to students and parents:

> The Winterset Community School District Board of Directors has authorized the use of recording devices in legally authorized locations in District buildings on school District buses. The recording devices will be used to help monitor and to maintain order in school buildings and on school buses to promote and maintain a safe environment for students and employees. Students and parents are hereby notified that the recording may be used in a student or employee disciplinary proceedings. The content of the recordings may be a confidential education record and handled in accordance with applicable law and Board policies regarding access to and disclosure of education records. Recording will be retained, if necessary, for use in a student or employee disciplinary proceeding or other matters as determined necessary by the administration. Parents may request to view recording which are an education record of their child to the extent permitted by law.

The following notice will also be placed on all school buses equipped with a recording device: "This bus is equipped with a recording/audio monitoring system."

The following notice will also be placed at District buildings:

"These premises are monitored by a recording monitoring system as permitted by lowa law."

#### Review of Recording Devices

Authorized personnel of the school District may review the recordings randomly or when necessary as a result of an incident. The recordings not otherwise saved will be routinely re-circulated for erasure.

Viewing of the recordings is limited to the school personnel having a legal right or legitimate educational purpose. A written log will be kept of those individuals viewing the recordings stating the time, name of individual viewing and the date the recordings was viewed.

#### Student Conduct

Students are prohibited from tampering with the recording devices on the school buses or District buildings. Students found in violation of this regulation will be disciplined in accordance with the school District discipline policy and will reimburse the school District for any repairs or replacement necessary as a result of the tampering.

#### Recording by Parents, Students or Visitors

Photography and recording audio or video is generally prohibited during the instructional day on District property, as it frequently materially interferes with the District's educational mission. Students, visitors, parents/guardians of students, and community members may take photographs, record audio or video or livestream public events held at school and may only do so during non-public events if authorized in advance to do so by a school staff member. A staff member may take photographs, record audio or video or livestream only if doing so assists in fulfilling the staff member's duties.

#### Recordings by Employees

No employee may make an unauthorized audio or visual recording of a conversation or meeting pertaining to District business unless the employee making the recording notifies all participants in the conversation or meeting of the recording. An employee making an authorized recording shall ensure that the recording device is located in plain view for the duration of the conversation or meeting. Secret recordings are prohibited and the use of these recordings may lead to disciplinary action, up to, and including termination.

These provisions are not intended to limit or restrict recordings involving authorized investigations conducted by District personnel or any meeting recorded in accordance with Board policy, including Board meetings, grievance hearings, and audio recordings of meetings or proceedings at which the substance of an employee grievance is discussed.

## Monitoring Devices

A parent or student shall obtain approval from the principal before operating technology allowing for remote recording or listen-in capability at school or at school-sponsored events. Because of student privacy concerns, the District requires remote listen-in technology to be disabled while the device is on District property. The District prohibits unauthorized audio or visual recordings or transmission of audio or images of other students.

# Water Testing

The long Department of Public Health requires school districts to conduct testing of all mater coolers and fountains for lead-containing sediment. The Wintersel Community School District has completed the required testing of all district mater coolers and fountains. All mater dispensers have been identified below 20 puln (0.020 mg/filer) as required by law. Additional information regarding specific testing results may be obtained by contacting the Director of Operations at (515) 462-2630.
