Welcome back to the 2022-23 school year. Included below are a few changes for the 2022-23 school year include:

- 1. **Food Service:** Will return to the regular cost program. Lunch applications must be completed and submitted to qualify for free or reduced meals. Please continue to monitor your child's lunch balance on the school app.
- 2. School App: Please download the school app on your phone or mobile device to have access to parent and student information. There will be staff available at Open House to assist you with this.
- 3. General Information: 2022-23 school year general opening information is included below.

Schuyler Community Schools has consistently followed guidance from the State of Nebraska and East Central Health Departments to maintain a safe and healthy environment. Therefore, in accordance with a recommendation from these agencies and CHI Health Schuyler, a limited number of masks have been purchased and will be distributed on an as-needed basis. The 100% In-School Learning model (Phase IV) remains our current Return-to-School model. Face-to-face instruction provides all students a structured learning environment in which they can ask questions, meet with support staff to discuss potential social emotional needs, access school meals, and engage in activities.

As we enter the 2022-2023 school year, we continue to ask for your patience and understanding as we work to continue to provide a safe and productive learning environment for our staff and students. We will continue to assess the situation and adapt or change as needed. Moving forward, building-specific information will be provided to you regarding the start of the school year. If there are changes to the school year, you will be notified in a timely manner.

Included with this letter and posted on the district webpage is Schuyler Community School District's "Return.to-Learn" plan. The "Return-to-Learn" plan provides detailed descriptions of the four phase plans that each school in Nebraska had to develop: Phase IV: 100% In-School, Phase III: In-School with modifications, Phase II: In-School with increased modifications or remote learning options, and Phase I: Remote and Online Learning. This plan can be found on the operational zones section of the Return to School Plan. Included in this mailing and posted on the district webpage is the "Return to School" plan for how we will be resuming student learning on August 10th.

DISCLAIMER: The COVID-19 situation is continuously evolving and there are still discussions taking place at the state level between the legislature and the Department of Education that could impact our plan to bring students back to school.

If your child(ren) will be late or absent, please call the school between 7:30 a.m. and 8:30 a.m. If assignments are needed, please request them in the a.m. Planned absences should be reported ahead of time. Afternoon absences should be called in by noon.

Extracurricular Activities - All students are encouraged to participate in school sponsored activities. Scheduled practices, meetings, etc. are under the supervision of an assigned sponsor. These activities must have the approval of the school administration. Wednesday nights will generally be reserved for family, church or community activities. Physical examinations performed by a medical professional are required in order to participate in extracurricular activities. Also, students entering Kindergarten and 7th grade are also required to have a physical exam prior to attending school in the 2022-23 school year.

Food Service: Lunch will begin on Friday, August 12. Breakfast and Lunch will begin on Monday, August 15th. Please complete and submit your free/reduced lunch applications as the Federal Food Service Program support ends on July 31st, 2022. Sack lunches may be brought, but they must be eaten in the lunchroom. Ala Cart may be purchased for an additional charge. Milk may be purchased for 35 cents.

□ Mask Guidelines

Due to the increasing numbers of Covid 19, Covid 19 Variant, and the potential cases of influenza, strep throat, etc. SCS will be implementing some triggers for instituting a mask mandate for our students and staff.

SCS cannot and will not be asking about health conditions and vaccination status, each person and family should exercise any additional precautions they see fit to be in attendance at school. We need both the community and parents' help to curb the spread of illnesses.

While masks are not mandated, employees and students who would like to wear them are encouraged to do so. If mandated, mask-wearing or other precautions <u>WILL NOT</u> be optional. There will be no contact tracing done by SCS, the health district, or any other medical institution. This is our best way of stopping community spread while still allowing students, staff, and families the freedoms they wish to keep regarding masks.

MASKS ARE RECOMMENDED AND NOT REQUIRED PK-12

Unless the board of education authorizes it's obligation through statute:

79-526. Class III or IV school district; school board; schools; supervision and control; powers.

(1) The school board or board of education of a Class III or IV school district has responsibility for the general care and upkeep of the schools, shall provide the necessary supplies and equipment, and, except as otherwise provided, has the power to cause pupils to be taught in such branches and classified in such grades or departments as may seem best adapted to a course of study which the board shall establish with the consent and advice of the State Department of Education. The board shall make provision for pupils that may enter at any time during the school year.

The board shall have a record kept of the advancement of all pupils in each branch of study. The board shall make rules and regulations as it deems necessary for the government andhealth of the pupils and devise any means as may seem best to secure the regular attendance and progress of children at school.

□What will trigger a mandate?

Our absentee rate for <u>ANY ILLNESS</u> that exceeds 8% across the district will result in a District Wide mask mandate for 15 school days (3 weeks) or until the rate subsides under the 8% if longer than 3 weeks. An absentee rate at 11% or above will result in a 48-72 hour shutdown of school to deep clean buildings. This will also result in a mandatory mask mandate for 15 school days (3 weeks) or until the rate subsides below 8%.
