18. Vote to approve or not approve letter of resignation from Peggy East, teacher aide and bus driver.

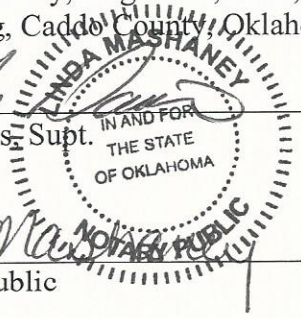
