I. Call to Order and Pledge of Allegiance

The meeting was called to order at 6:35 p.m.

- b. Round Table. Trustee Marshall is very pleased with the presentation about the new school playground. The old playground structures will not be sold or donated, but will be disposed of. Trustee Pullis reported on the recent newspaper article she read which highlighted seven ODY students who are this year's recipients of the Clark Foundation Scholarship. She also read about the ODY Vectorworks class taught by Mr. Derick Waters, and she was pleased to see photographs in the newspaper from the PTO Literacy Night. Trustee Pullis commented on a program that might be considered for ODY students, whereby SUNY Oneonta students teach

high-schoolers about hydroponics. Superintendent Fahey responded that the ODY Guidance Counselor Alicia Soper and Science Teacher Jeff Rupp are exploring the possibility of such partnerships for the future. It was noted that most of the school news articles are covered in the Richfield Springs area publications. President Tharp and the BOE would like to see more ODY school events published in other local newspapers in the Mohawk Valley.
