 - i. Superintendent's evaluation was distributed.
- President Tharp reported that at a recent BOCES meeting it b. Round Table was determined that NYSED will provide direction regarding a replacement for former BOCES Superintendent Dr. Mark Vivacqua. Regarding a different matter, Central Valley Academy is currently waiting for its Capital Project, while ODY bids are due March 1st at 1:05 P.M. The Agriculture Committee will meet on February 15; schools and participants have been re-canvassed in preparation for the May event at the Frankfort Fairgrounds. Trustee Kennerknecht asked if the names of Honor Roll members could be published in the local newspaper. Superintendent Fahey will look into it and will consult Andy LaLonde. Trustee Mower asked if the Board would be able to contact Education Commissioner Mary Ellen Elias to let her know how outrageous her recent actions are regarding Carl Palladino. President Tharp suggested that Superintendent Fahey bring the issue to the BOCES Cabinet. Trustee Pullis complimented Superintendent Fahey on his quick response during the recent incident involving the police who were dealing with a domestic dispute during the morning bus run. She reported that she and Superintendent Fahey attended a public hearing at Mount Markham CSD regarding opening its agriculture program to other districts. Trustee Pullis discussed the hydroponics program at SUNY Oneonta. Trustee Mower asked if ODY could build a greenhouse and develop a program in hydroponics, and

possibly offer a course in operating farm equipment, creating an interdisciplinary approach. Superintendent Fahey responded, saying that scheduling would be a concern. In March Trustee Pullis will be in Mrs. Beam's grade 2 class as part of the Agri-Literacy initiative. Trustee Pullis asked to what extent students are able to learn employment skills, and Superintendent Fahey answered that this is addressed in the Career and Financial Management class. Trustee Pullis concluded by discussing whether or not the PTO would be able to continue due to the lack of active members. Trustee Mower addressed the letter written to Board members by an anonymous writer expressing concern that ODY is employing an uncertified Science teacher while not actively seeking a certified teacher at this time. Superintendent Fahey replied that the current Science teacher is taking appropriate coursework and is scheduled for permanent certification in both Living Environment and Earth Science. The ODY Science position may be reopened in the future if these criteria are not going to be met for the 2017-18 school year. The letter writer appears to have accessed incorrect information that was not updated and current on the NYSED website regarding the Science teacher's certification NYSED is aware of the shortage of Science and Math teachers. Trustee Mower expressed that it is unfortunate that uninformed people assume that they are aware of the facts when they are not.
