Trustee Kennerknecht asked what standards are in place to ensure that Special Education services are being implemented in a legal manner. He also asked if the district should invite a ski patrol instructor to speak to students in Ski Club to present information about safe skiing practices. Board members agreed that this is a good idea. Trustee Kennerknecht concluded by addressing the WiFi blocks that exist at school. Superintendent Fahey will consult Mr. Corleto about options that would allow greater public

access.

Trustee Mower addressed his concerns regarding charter schools and vouchers.
