- a. Science Fair presentation. ODY teachers Denise Snell Hayes, Rachel Shepardson and Laura Trier spoke to the Board, outlining their work thus far in preparing for the Spring 2017 ODY Science Fair. Academic Coach Mr. Mark Dunn stressed the important role of the Library Media Specialist in the Science Fair, and the need to incorporate a writing component as part of the final project.
- b. Cwynar & Co. Audit presentation. Mr. Cwynar presented his findings from the audit of ODY financial statements dated June 30, 2016.
- c. Student Council Representatives King and Queen. Grade 12 students Anthony Ciaccia and Nick Hula, presenting on behalf of the Student Council, would like to see the tradition of crowning a Prom King and Queen continue. Discussion followed regarding whether or not to crown grade level kings and queens, and if doing so was an unfair popularity contest. VIII. BOARD FORUM

a. President's Report President Tharp discussed the Board to Board newsletter from Herkimer Fulton Hamilton Otsego BOCES dated October 2016. President Tharp noted the pending retirement of school attorney Benjamin Ferrara and praised his efforts in representing ODY. The Summer 2016 Rural Futures document was reviewed and all recognized its value.

President Tharp began with a discussion about BOCES b. Round Table administrator Laurie Hedges having a key to appropriate websites; Superintendent Fahey has this directory. President Tharp proceeded to discuss the importance of noting not only individual academic achievement but recognizing overall student growth. Trustee Marshall inquired if ODY has a Future Farmers of America program; the school does not. In order to have an FFA the school would need to have an agricultural program. Trustee Kennerknecht asked if the Board would consider asking teachers to post homework assignments on the school website. Trustee Pullis noted the upcoming Fall Festival scheduled for October 22, and the many attractions slated for the day. President Tharp asked if the media would be present; Trustee Pullis said not this year, although she did reach out to the Pennysaver with information about the event. Trustee Pullis mentioned that two ODY classes, including Residential Structures taught by Mr. Derick Waters, would soon be visiting her family farm.
