# **Allison Health Clinic (AHC)**



#### Q. Are school nurse services still available?

A. Yes, the school nurse will continue to follow the same routine services when the child's teacher sends the student to the office.

## Q. Can my child be sent to the Allison Health Clinic directly from my child's homeroom?

A. No. All students must follow the same protocol by reporting to the nurse's office first. In the event a child may be recommended by the school nurse to go to the AHC, the parent/guardian will receive a phone call from the school nurse or principal to discuss the next steps.

# Q. Will the parent or guardian be contacted if the child goes to the Allison Health Clinic?

A. Yes. Parent/guardian will be called before a child is sent to the AHC. Children can only receive services from the AHC if an Enrollment and Parent Consent is on file.

#### Q. Where will the Allison Health Clinic be located?

A. The ACH will be located in an existing office near the school library.

#### Q. Who can be seen at the Allison Health Clinic?

A. Children must be enrolled at Allison Elementary School or New Manchester Elementary School with an Enrollment and Parent Consent form on file.

#### Q. How will my child get to the Allison Health Clinic?

A. When parents/guardians are not available, children will be escorted to the clinic by school personnel or staff.

# Q. What should I do if I do not want my child to receive Allison Health Clinic services?

A. An Enrollment and Parent Consent form does not need completed nor sent back to school if the parent/ guardian does not want their child to receive services from the AHC.

# Q. Can the child's parent/guardian take the child to the Allison Health Clinic?

A. Yes. Parents can take the child to the AHC.

# Q. Do parents need to be present?

A. Parents do not have to be present if a signed Enrollment and Parent Consent is on file.

# Q. How will I know what is going on with my child's health?

A. This is a principle goal of Allison Elementary School and the Allison Health Clinic. Therefore, parents/guardians will be in contact by the AHC staff as necessary.

#### Q. How do I make an appointment?

A. Call Allison Elementary School and our staff will assist you in scheduling an appointment between the hours of 9:00-1:00 that works with your schedule <u>and</u> with your child's class schedule.

### Q. Who will my child see in the Allison Health Clinic?

A. The AHC will be staffed by pediatrician, Dr. Lisa Noble, Hannah Reynard, Nurse Practitioner, and their office staff.

#### Q. Will they write a prescription for my child?

A. If it is determined that your child needs a prescription medication, a script will be written for the child by the licensed professional. The script can be electronically sent to your desired pharmacy.

# Q. Who would have access to my child's medical records?

A. All medical records are confidential as they are part of the Weirton Medical Center records system. Before we can share any records, parents/legal guardian must sign the Enrollment and Parent Consent form.
