




#### **PURPOSE**

# Health and Safety Guide for the 2021-2022 School Year, NYSED

#### 2021-2022 Goals

- Keep students and staff healthy and safe.
- · Be responsive to student needs.
- Maximize in-person teaching and learning.

- Academy of Pediatrics' COVID-19 Guidance for Safe Schools.

- Local, state, and national resources available to schools.

#### Letter from the Otsego County Department of Health

#### Important Considerations:

- Delta variant is the predominant strain
- Vaccination is currently the leading public health prevention strategy
- Extremely important that children return to the in-person learning environment with layered prevention strategies in place.
- High-risk sports and extracurricular activities should be virtual or cancelled in areas of high transmission unless all participants are fully vaccinated.

Guidance based recommendations provided by the American Academy of Pediatrics (AAP) and the Centers for Disease Control and Prevention (CDC)

Recommends K-12 schools adopt universal masking for staff, students and visitors, regardless of vaccination status

Safely returning all students to inperson instruction is a priority

- Strongly advocates that all policy considerations for school plans should start with the goal of keeping students safe and physically present in school.
- Remote learning highlighted inequities in education, was detrimental to the educational attainment of students of all ages and exacerbated the mental health crisis among children and adolescents.
- Opening schools generally does not significantly increase community transmission, particularly when guidance is followed.
- There are **still possibilities for transmission of SARS-CoV-2**, especially for individuals and families who have chosen not to be vaccinated or are not eligible to be vaccinated. Variants have also emerged that may increase the risk of transmission.
- The AAP believes that, at this point in the pandemic, given what we know about low rates of in-school transmission when proper prevention measures are used, together with the availability of effective vaccines for those age 12 years and up, that the benefits of inperson school outweigh the risks in almost all circumstances.
- Schools and school-supported programs are fundamental to child and adolescent development and well-being provide our children and adolescents with academic instruction; social and emotional skills, safety, reliable nutrition, physical/occupational/speech therapy, mental health services, health services, and opportunities for physical activity, among other benefits.
- Families rely on schools to provide a safe, stimulating, and enriching space for children to learn; appropriate supervision of children; opportunities for socialization; and access to school-based mental, physical, and nutritional health services.



- Students benefit from in-person learning, and safely returning to in-person instruction in the fall 2021 is a priority.
- Vaccination is the leading public health prevention strategy to end the COVID-19 pandemic. Promoting vaccination can help schools safely return to in-person learning as well as extracurricular activities and sports.
- CDC recommends universal indoor masking by all students (age 2 and older), staff, teachers, and visitors to K-12 schools, regardless of vaccination status.
- Students, teachers, and staff should stay home when they have signs of any infectious illness and be referred to their healthcare provider for testing and care.
- Maintain at least 3 feet of physical distance between students within classrooms to reduce transmission risk. When it is not possible to maintain a physical distance of at least 3 feet, it is especially important to layer multiple other prevention strategies, such as screening testing.
- Screening testing, ventilation, handwashing, and respiratory etiquette, staying home when sick and getting tested, contact tracing in combination with quarantine and isolation, and cleaning and disinfection are also important layers of prevention to keep schools safe.
- Many schools serve children under the age of 12 who are not eligible for vaccination at this time. Therefore, this guidance emphasizes implementing **layered prevention strategies** to promote in-person learning.
- Localities should monitor community transmission, vaccination coverage, screening testing, and occurrence of outbreaks to guide decisions on the level of layered prevention strategies.

### CDC update 8.12.21

Given new evidence on the B.1.617.2 (Delta) variant, CDC has updated guidance for fully vaccinated people. CDC recommends universal indoor masking for all teachers, staff, students, and visitors to K-12 school, regardless of vaccination status. Children should return to full-time in person learning in the fall with layered prevention strategies in place.

# Layered Mitigation Strategies

**Vaccination** 

Universal Masking

#### Vaccination

Vaccination is the leading public health prevention strategy to end the pandemic

# Universal Masking

Universal indoor masking for all staff, students, & visitors regardless of vaccination status

# Physical Distancing

Classrooms with 3ft distancing, using desks and tables

Cafeterias with 3ft distancing using alternating seats at tables

Band, Chorus, PE with 6ft as possible

# Handwashing and Respiratory Etiquette

Cover coughs and sneezes

Encourage handwashing with soap and water for at least 20 seconds

#### Temperature and Questionnaire Screenings

The CDC no longer recommends temperature screenings or screening questionnaires at school

# Cleaning & Disinfecting

Will clean and disinfect classrooms and buses daily

#### Ventilation

Building ventilation systems are currently being assessed

#### Monitoring Community Transmission

Consult with local health officials and monitor community transmission, vaccination coverage, screening testing, and occurrence of outbreaks

#### Transportation



### Remote Learning

Shift as a district to remote learning based on public health conditions

Districts not required to offer remote learning option

Will evaluate educational needs of medically homebound students as identified

### Contact Tracing and Quarantine

#### No Quarantine:

Student/staff masked appropriately within 3ft of positive

#### Quarantine:

Unvaccinated person within 6ft unmasked longer than 15 minutes

Collaborate with local health departments and report new diagnoses of COVID-19

#### Social Emotional

Counselors will reach out to all families that remained fully remote last year as well as our students with disabilities.

We will be offering an Employee Assistance Program.

#### Sports and Extracurriculars Activities

The CDC and NYSED recognize that school-sponsored sports and extracurricular activities provide students with enrichment opportunities that can help them learn and achieve and support their social, emotional, and mental health.

#### Recommended Prevention Strategies

Follow the same school-day policies and procedures during athletic and extracurricular activities

Students should refrain from these activities when they have symptoms consistent with COVID-19 and should be tested.

Encouraged to use COVID-19 screening testing for student athletes, students participating in extracurricular activities or other activities with elevated risk

# Community Transmission Status Related to High-Risk Sports

Otsego County Department of Health reports that the level of community transmission is high.

NYSPHSSA will support District decisions for Fall sports

Section III Football reiterated NYSPHSSA has not made recommendations; therefore, decisions will be up to local DOH and/or Districts.

Section III Athletic Director meeting indicated that all schools are planning to move forward as normal

Otsego County districts offering football and volleyball are planning to move forward as planned.

#### **Football Options**

Allow football to continue as scheduled and require masks, unless the Option I local DOH, NYSED, or NYSPHSSA mandate cancelling the season Allow the football season to continue as scheduled and require Option II COVID-19 screening testing for student athletes and coaches. Option III Cancel the football season.
