# Requirements for Pre-K, K, 2nd, 7th, and 12th Grade Students



#### Pre-K

Since Pre-K students are new to the school system, they are required to have the following documents to begin school:

- A Yellow Card with the state approved immunizations, stamped by the Wyoming County Health Department;
- A comprehensive health exam (Health Check);
- A dental exam signed by a dentist or licensed hygienist; and
- Vision and hearing exam completed with the health check exam or by a separate provider.

#### Kindergarten

Kindergarten students that have not attended Pre-School or Head Start are <u>required</u> to have the same items as Pre-K. However, they will need updated immunizations. Their immunizations should be on a green card stamped by the Wyoming County Health Department. If the K student attended Pre-K or Head Start, the only new requirement is that updated immunizations are on a green card stamped by the Wyoming County Health Department.

#### 2nd Grade

It is recommended that students entering the 2nd grade have an updated dental exam and comprehensive health exam.

#### 7th Grade

It is recommended that students entering the 7th grade have an updated dental exam and comprehensive health exam.

All students entering the 7th grade are <u>required</u> to show proof of immunizations required by the state: Menactra or MCV4, and Tdap. Immunization proof should be provided to the Wyoming County Health Department for documentation on their blue card.

#### 12th Grade

Students entering the 12th grade have the same requirements as 7th graders.

## West Virginia Immunization Requirements for New School Enterers

State law and rules1 require that all children entening school in West Virginia for the first time in grades K-12 must show proof of immunization against diphtheria, pertussis, tetanus, polio, meastes, mumps, rubella, varicella and hepatitis B unless properly medically exempted. The table below outlines immunization requirements as most commonly met. The West Virginia Bureau for Public Health recommends that vaccine doses administered 4 days or fewer before the mirmum interval or age should be considered valid

Varicella	Before admission, two doses required. First dose must be after the 1 <sup>st</sup> birthday. Medical exemptions must be requested by a physician who has treated or examined the child and be reviewed and approved by the local health officer in the county in which the child attends school. Requests for exemptions must be based on current standards of immunization practice and include the following information: the vaccine(s) being exempted, the specific medical reason for the exemption, whether the exemption is temporary or permanent, and, if temporary, when the exemption should be reevaluated. ## **School Entry Immunization Requirements** for 7th and 12th Graders

#### Dear Parent.

Vaccines save lives and protect our children. When young children are about to enter PreK and kindergarten for the first time, parents have to make sure that their child is up to date on their shots. However, young children are not the only ones that need shots.

Students entering 7th grade and 12th grade now have shot requirements. These requirements must be met before they can start school or take part in sports or extracurricular activities. Children that are current with their adolescent shots may have already met the new requirements, however many have not. The following shots are required before the beginning of the school year:

- 7th Graders must show proof of a booster dose of Tdap vaccine, which protects against tetanus, diphtheria, and pertussis (whooping cough) and a dose of the meningitis vaccine.
- 12th Graders also must show proof of a single dose of Tdap and a booster dose of the meningitis vaccine. If the first dose of meningitis vaccine was given after the 16th birthday, then a booster dose of meningitis vaccine is not required.

Vaccines are one of the most cost-effective preventive measures available and have saved countless lives. The new adolescent immunization requirements will not only lengthen the time for which immunized students are protected from vaccine-preventable diseases, but will also lower their chances of passing diseases to the elderly, children and infants, or classmates with weakened immune systems. Immunizations help keep adolescents healthy and prevent problems as they grow older.

Take your adolescent to their health care provider for a routine adolescent check-up to determine if your teen's shots are current and to meet the 7th and 12th grade school entry immunization requirements. Adolescents who are found to be missing shots can receive them during that visit. Teens without a family doctor/health care provider may visit a local provider, or the Wyoming County Health Department, for immunizations.
