- III. Superintendent Updates
  - Many of our administrators attended the GAEL conference this week.
  - Ms. Murphy and Dr. Brooksher have been invited to attend BCRH Chamber meetings.
  - We concluded our summer experience with a little over 600 students in attendance.
  - We are studying close contacts and quarantine. We do not require our students or staff to get a COVID vaccine.
  - A back to school e-mail blast will go out on July 19<sup>th</sup>.
  - We are going back to traditional open houses. Richmond Hill Middle School will offer traditional and virtual.

- K-5 school lunch procedures will be changing for the next school year.
- First day of school drop-off procedures for Kindergarten and Pre-K will change for the next school year.
- New Teacher Orientation begins next week and we will be welcoming 96 new teachers. Board members are invited to attend orientation on the morning of July 23<sup>rd</sup> at Frances Meeks Elementary School.
- Dr. Brooksher shared a request he received to switching November 11<sup>th</sup> and 12<sup>th</sup> for staff and moving the professional learning day to Friday. Dr.
   Brooksher would like to survey the staff first before bringing forward to the board for consideration.
- Dr. Brooksher has purchased a table for the CURE dinner on September 25<sup>th</sup>
   and would like to invite the board to attend.
- Dr. Brooksher will share results with the board from the Exemplary Committee survey.
- The GSBA Governance Team of the Year application was submitted yesterday.
- Lanier Primary School will be renamed to Lanier Learning Center.
- There will be a process to preserve the mural at Bryan County High School and redesign the wall in the cafeteria.
- Our back to school Leadership Development is on Monday at Richmond Hill
   Elementary School. The board is invited to come welcome everyone back.
- Ms. Melanie James and Ms. Toni Williams shared a new requirement that goes into effect on July 1<sup>st</sup>. This change will require us to adjust the

formatting of the financial report that is presented at each board meeting for approval.
