# 2021-2022 School Year Quarantine/Contact Tracing Information (Updated December 8, 2021)

\*\*Please do not send your children to school if they are sick\*\*

# **BEST HEALTH PRACTICE**

- All students, families, and staff members will need to complete the <u>self-assessment</u> prior to riding a school bus or coming to school.
- East Grand Forks Public Schools highly recommends vaccination against COVID 19 for anyone who is eligible. To find out upcoming area Covid-19 Vaccine clinics, please visit <a href="https://www.co.polk.mn.us/191/Public-Health">https://www.co.polk.mn.us/191/Public-Health</a>.
- The East Grand Forks Public School District is highly recommending face coverings when indoors.

# **HOW TO AVOID QUARANTINE (if identified as a close contact)**

If you meet <u>one</u> of the following criteria in most case scenarios, you will avoid having to quarantine.

- If you are fully vaccinated (i.e. 2 weeks following receipt of the second dose in a 2 dose series, or 2 weeks following receipt of a one dose of a single-dose vaccine for COVID-19 and not experiencing symptoms.
- If you have tested positive for COVID-19 and are not experiencing symptoms, you will not need to be quarantined for 90 days following their positive test if documentation of the positive test is provided.
- If you are consistently wearing your face-covering and not experiencing symptoms.

# QUARANTINE CONTACT TRACING

**LEVELS 1-2** 

#### SYMPTOMATIC STUDENTS AND STAFF

#### SYMPTOMS TO LOOK FOR:

If a child or staff member has any of the following symptoms, they should stay home and notify the school of attendance: <u>fever 100.4 F or higher; new cough or cough that gets worse;</u> <u>difficulty/hard time breathing or loss of taste and or smell **OR** two (2) of the LESS COMMON symptoms: <u>extreme fatigue, new severe/ very bad headache, muscle/body aches, chills, cough, shortness of breath, sore throat, new nasal congestion/runny nose, nausea, vomiting, diarrhea, abdominal pain.</u></u>

### **CONTACT TRACING OF POSITIVE STUDENTS and STAFF**

**How close contacts are identified:** When a staff or student is within 3 feet of someone for 15 minutes or greater.

# **Social Close Contacts**

If a student or staff member is identified as close social contact, is not symptomatic, and not met one of the bulleted criteria listed below, they will be contacted by a COVID team member via email, text, or voice call.

- they are fully vaccinated.
- they are in the 90-day window after testing positive for COVID-19 and have provided documentation of the positive test.
- they are consistently wearing a face covering.

A <u>sample of the written correspondence</u> is as follows. Please note that quarantine and masking will be recommended and not required.

Dear Parents and Guardians,

The primary reason for this letter is to inform you about recent positive COVID-19 case in your child's classroom. If your child develops symptoms, please keep your child at home and contact your child's school. COVID-19 testing is encouraged, especially if the symptom persists, worsens, additional symptoms develop, or when COVID-19 transmission is substantial or high in the community.

As a parent/guardian you also have the option to quarantine. If you choose to quarantine, please call the school your child attends so someone from the COVID-19 team can give you a return date. We are also highly recommending having your child wear a face-covering for the next 14 days while attending school. Just as a reminder, COVID-19 symptoms fall into two groups:

<u>More common</u> symptoms are one or more of the following. A fever of 100.4 degrees Fahrenheit or higher; new cough or a cough that gets worse; difficulty/hard time breathing; and new loss of taste or smell.

<u>Less common</u> symptoms include two or more of the following. A sore throat; nausea; vomiting; diarrhea; chills; muscle pain; extreme fatigue/feeling very tired; new severe/very bad headache; and new nasal congestion/stuffy or runny nose.

# **Household Close Contacts**

If a student or staff member is determined to be a household close contact, they will need to follow quarantine guidelines listed below unless they are fully vaccinated and symptom-free or in the 90-day window after testing positive for COVID-19 and have provided documentation of the positive test.

- They will be released from quarantine **AFTER DAY 10** from last exposure if they remain symptom-free.
- If they develop symptoms, a negative Covid-19 test is required to be released from quarantine or the student or staff member needs to quarantine for 10 days from onset of symptoms. - The Minnesota Department of Health recommends that your child or staff quarantine for 14 days from their last exposure to someone who tested positive with COVID 19.

# **LEVELS 3 and 4**

#### SYMPTOMATIC STUDENTS AND STAFF

## **SYMPTOMS TO LOOK FOR:**

If a child or staff member has any of the following symptoms, they should stay home and notify the school of attendance: <u>fever 100.4 F or higher; new cough or cough that gets worse;</u> <u>difficulty/hard time breathing or loss of taste and or smell **OR** two (2) of the LESS COMMON symptoms: <u>extreme fatigue, new severe/ very bad headache, muscle/body aches, chills, cough, shortness of breath, sore throat, new nasal congestion/runny nose, nausea, vomiting, diarrhea, abdominal pain.</u></u>

# **CONTACT TRACING OF POSITIVE STUDENTS and STAFF**

Exemptions are subject to change based upon CDC and MDH guidance.

If a student or staff member is identified as close contact and has no symptoms, they can be **exempted from quarantine if one of the following is true**:

- they are fully vaccinated.
- they are in the 90-day window after testing positive for COVID-19 and have provided documentation of the positive test.
- they are consistently wearing a face covering.

If students or staff are not exempt one of the following options is available.

- The person may be released from quarantine AFTER DAY 7 from last exposure if they remain symptom-free and test negative for the COVID-19 PCR test on or after day 5 after their last exposure to the positive person. - The person may be released **AFTER DAY 10** from the last exposure if they remain symptom-free.
- The Minnesota Department of Health recommends that your child or staff quarantine for 14 days from their last exposure to someone who tested positive with COVID 19.

When a staff or student is within 3 to 6 feet of someone for 15 minutes or more throughout the course of a day (24 hours).
