1. The meeting was called to order by Secretary Misty Lucherk. A prayer was given by Demetrius Colvin, Sr., and the Pledge of Allegiance was led by Jeff Harmel.

- 5. a. Nominations for president were opened. Ronnie Hohlt nominated Misty Lucherk for president, and Felton Cox nominated Demetrius Colvin, Sr. for president. A motion was made by Mr. Hohlt and seconded by Mr. Harmel that all nominations cease. Motion passed unanimously. Ronnie Hohlt and Misty Lucherk voted for Misty Lucherk. Felton Cox, Demetrius Colvin, Sr., Jeff Harmel, and Ande Bostain voted for Demetrius Colvin, Sr. Demetrius Colvin, Sr. was elected president by a vote of 4-2.

- 7. Superintendent's Report
  - a. Superintendent Kennedy presented an update on the old rock high school building renovation project. A pre-construction meeting was held on May 18, 2015. Charles Hodde will be the district construction manager through June 25, 2015.
  - b. The Summer Leadership Conference for the board will be held in San Antonio June 11-13, 2015.
- 8. A motion was made by Mrs. Lucherk and seconded by Mr. Cox to approve the consent agenda as presented. Motion passed unanimously.
- 9. No action was taken regarding the Washington County EMS Interlocal Agreement between the City of Burton and Burton Independent School District.
- 10. A motion was made by Mr. Hohlt and seconded by Mrs. Lucherk to name the agriculture building after Charles Hodde. Motion passed unanimously.
- 11. a. I, Ande Bostain, move that we accept the recommendation of the Superintendent to employ Nicholas Herr as the new agriculture teacher on a one year probationary contract. His contract will be for 226 days. The motion was seconded by Misty Lucherk. Motion passed unanimously.
  - b. A motion was made by Mr. Hohlt and seconded by Mr. Bostain to the accept the resignation of Tracey E. Cox effective June 1, 2015 and Edith Suzanne Bradford as a full time Speech/Language Pathologist for the Burton Special Services Cooperative. Motion passed unanimously.
- 12. A motion was made by Mr. Bostain and seconded by Mr. Harmel to employ Edith Suzanne Bradford as a part-time Speech/Language Pathologist for the Burton Special Services Cooperative based on the recommendation of the Burton Special Services Cooperative superintendents of Burton, Dime Box, and Round Top-Carmine for school year 2015-2016. Her contract will be for 85 days. Motion passed unanimously.
- 13. A motion was made by Mr. Hohlt and seconded by Mr. Bostain to adjourn at 7:33 p.m. Motion passed unanimously.
