- 1. The meeting was called to order by President Marcus Broesche. A prayer was given by Demetrius Colvin, Sr., and the Pledge of Allegiance was led by Ronnie Hohlt.

3. Principals' Report

a. Karen Steenken, secondary campus principal reported the enrollment at the secondary campus is 173 students. $(7^{th} - 26, 8^{th} - 30, 9^{th} - 35, 10^{th} - 42, 11^{th} - 22, 12^{th} - 18)$.

- 4. Superintendent's Report
