DEFINING THE AMERICAN RESCUE PLAN

- The American Rescue Plan
- ARP ESER III Overview: The American Rescue Plan (ARP) Act of 2021, Public Law 117-2, was enacted on March 11, 2021. The ARP Act provides additional funding for school districts to respond to the COVID-19 pandemic. The Education portion of ARP is known as the Elementary and Secondary School Emergency Relief (ESSER III or ARP ESSER) Fund.
- General grant specifics are as follows:
- Grant Timeframe: Grant expires September 30, 2023. If needed, districts can carry over unused funds and be allowed to continue spending until September 30, 2024.
- Districts will be required to follow all federal, state, and local regulations and requirements for federal grant administration and fiscal spending of funds.
- NCLUSD has been allocated 4,477, 980(estimate) to be expended over a 3-year period.

ARP ESSER III PURPOSE

The purpose of the ARP ESSER III fund is to address learning loss and support the safe reopening and sustaining safe operations of schools while meeting students' academic, social, emotional, and mental health needs resulting from the COVID-19 pandemic. These funds address the impact that COVID-19 has had and continues to have on elementary and secondary schools.

LEARNING LOSS

■ ESSER III requires that at least 20% of the funds be spent addressing learning loss due to the Pandemic.

REQUIREMENTS ESSER III

- NCLUSD has been allocated 4,477,980(estimate)
- Unlike other grants the ESSER III does not have a specific allocation for campuses. This grant is for NCLUSD
- The two primary requirements are:
- Use of Funds Plan
- 2. Safe Return to In-Person Instruction and Continuity of Services

NCLUSD PLANS TO USE ESSER FUNDS FOR

- I. PROVIDE STUDENT ACADEMIC SUPPORT AND INTERVENTION IN ORDER TO CLOSE GAPS IN LEARNING CAUSED BY THE COVID-19 PANDEMIC.
- 2. IMPLEMENT A DISTRICT-WIDE SOCIO-EMOTIONAL LEARNING PLAN TO ADDRESS MENTAL HEALTH AND STUDENT BEHAVIOR.
- 3. SUPPORT TEACHERS IN FURTHER DEVELOPING AND IMPLEMENTING INSTRUCTIONAL METHODOLOGIES TO ADDRESS ALL TYPES OF LEARNING, LEARNING PLATFORMS, AND DIVERSITY IN LEARNING.
- 4.TO FURTHER PROVIDE INSTRUCTIONAL TRAINING, SUPPORT, TECHNOLOGY, AND MATERIALS.

SAFE RETURN AND CONTINUITY OF SERVICES

- 1) NCLUSD WILL DEVELOP A RETURN TO INSTRUCTION AND CONTINUITY OF SERVICES PLAN, TO ADDRESS DISTRICT NEEDS.
- 2) NCLUSD WILL DEVELOP A USE OF FUNDS PLAN, THAT SUMMARIZE NCLUSD ESSER III EXPENDITURES.
- 3) BOTH PLANS WILL BE POSTED UNDER THE ESSER III TAB ON THE WEBSITE.
- 4) NCLUSD WILL USE RECOMMENDATIONS FROM ALL STAKEHOLDERS WHEN MAKING DECISIONS ABOUT THE CONTINUITY OF SERVICES PLAN, OR HOW TO USE THE FUNDS SET ASIDE FOR NCLUSD.
- 5) THE RETURN TO INSTRUCTION, AND CONTINUITY OF SERVICES PLAN, WILL BE REVIEWED AT LEAST EVERY SIX MONTHS.

NCLUSD WILL REVISIT THE RETURN TO IN PERSON INSTRUCTION, AND CONTINUITY OF SERVICES PLAN AT LEAST EVERY SIX MONTHS, TO MAKE SURE THAT FUNDS ARE BEING SPENT TO ADDRESS THE MOST CURRENT NEEDS OF NCLUSD.
