**SUPERINTENDENT’S REPORT**

Summer cleaning of the buildings are 95% complete. Staff has done a great job and have a goal of completing by August 1.

Summer reading camp will be the first week of August. We currently have 60-65 students signed up to attend.

The light replacement is near completion and staff will have training on the operation of those lights.

The athletic department has looked into having cameras placed on the football field and Cooper gym to broadcast home sporting events. The cost for the subscriber will be \$11/month or \$69.99/year. This will not cost the District any money but we will have to sign a 5 year contract. The athletic department will receive 10% per subscriber per event or \$20 per subscriber who signs up for a whole year. The contract is through the National Federation of High School Sports and is in coordination with OHSAA. The Board had no issue with pursuing this option but wanted Mr. Baldwin to check into allowing more than just sporting events (graduation, Christmas program, etc.) to be broadcast.
